Pond #6 last to be cleaned. Previous plans abandoned due to sediment deposit location effects wet land restrictions.

Had company estimate the sediment amount in summer of 2016 for accurate cost to clean. Est. 5,300 Cubic Yards.

130K to dredge pond. Most expense is the hauling sediment off site. Nowhere on site to spread it out.

At current cost, the HOA can clean this year but would drain most of the saved funds.

Tentative plan is to meet with 6 home owners that border pond with a contractor to review plan, we hope to do pond over the winter 2019/2020 to save money and put costs into 2 year budget

Lots of discussion on this project;

Blue-Green Algae showed up in pond #4 Sept 2016. We have had 2 years free of this issue. These blooms are common throughout Ohio. They are harmful in that when the algae die off because they have grown out of control, they can release a toxin which is harmful to wildlife and people. The best plan of action would be to recognize the bloom when it is happening so that Aqua Doc can treat the pond. People should shut their aerators down and not have contact with the pond water until the algal bloom is resolved.

These algae come from build-up of prosperous in the sediment from lawn fertilizer run-off. It will most likely come back.

Pond water needs to be 60 F + for AquaDoc to treat. There is a green/black alga (spirogyra) in the spring of the year. I am aware of this and it will be treated as soon as the water warms up.
