2. The commission structure will be 10% of the invoice value excluding transportation & taxes.
3. Buying/Export house/applicants will provide the details of country for targeting business and will valid for only 12 months.
4. Buying/Export house/applicants will provide the details of PSUs for targeting business and will valid for only 12 months.
5. Jharcraft will provide brochures, catalogues, documentary movies.
6. Jharcraft will send 20 cm. samples of each swatch along with details of different product to your organization.
7. Jharcraft will help you in design development of different products.
8. Expenses for designer and for designing the samples will be borne by the Jharcraft, but only after prior approval.
9. For costing of each sample you need approval from Jharcraft.
10. Jharcraft will stuck developed products only for 90 days, after that Jharcraft will be entitled to sale the developed products.
