City Council Minutes

July 1st, 2019

The City Council of the City of New Munich met in regular session at 6:30 p.m., in the City Hall. Jim Poepping, Shawn Duevel, Elmer Boecker, Ron Doll were present. Pat Nathe was absent.

On a motion by Shawn Duevel, seconded by Ron Doll and carried the minutes from June 3rd, 2019 were approved.

Justin Boecker from the Fire Department was present to inform the Council there were 2 medical calls in June. He was also letting the council know they would like to purchase a tv for their department that will be used for trainings. He also presented the following bills, Batteries for air packs \$208.91, Action Training \$693.59 & \$2,042.47, St. Cloud Technical College \$750.00 (Training).

Waste /Water Operator, Tom Valerius was present to inform the Council that Bob from H & H will be cleaning and inspecting the water towers.
