Shop Local Sweepstakes Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. MAKING ANY TRANSACTION WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR RESTRICTED. THIS SWEEPSTAKES IS SUBJECT TO ALL APPLICABLE FEDERAL, STATE, AND LOCAL LAWS AND REGULATIONS. The Holden Area Chamber of Commerce Shop Local Sweepstakes (this "Sweepstakes") begins at 12:00:01 AM Central Time on November 4, 2022, and ends at 11:59:59 PM Central Time on November 25, 2022 (the "Sweepstakes Period").

ELIGIBILITY. This Sweepstakes is open only to legal residents of Missouri (the "Eligibility Area") who are eighteen (18) years of age or older at the time of entry. Only individuals may enter; no entries from corporation or other entity shall be accepted. This Sweepstakes is VOID outside of the Eligibility Area. Members, officers, and directors of The Holden Area Chamber of Commerce and their respective affiliates, subsidiaries, advertising, sweepstakes, fulfillment, marketing agencies, public relations firms, consultants and contractors, their immediate families (defined as spouse, child, sibling, parent, or grandparent) and those living in their same households are ineligible to participate in this Sweepstakes.

Individuals will complete the entry card and place all entry cards in the designated collection box at Yoss Bros grocery store at 1200 E. 10th Street, Holden, MO 64040 between the hours of 7 am and 8 pm Monday through Sunday, except Thursday, November 24, 2022. **Alternate Method of Entry:** An individual may enter by printing legibly his/her complete name, physical mailing address, email address, telephone number, date of birth, and the label "Holden Area Chamber of Commerce Sweepstakes Entry" on a 3"X 5" card and mailing it to:

Regardless of Method of Entry: Entries received by Administrator after the end of the Sweepstakes Period will be discarded and deemed void. No changes to any entry information will be permitted once submitted. No mechanically reproduced or photocopied entries are permitted.
