

"Reap the Whirlwind"

"They sow the wind and reap the whirlwind."

Hosea 8:7

Recently a man brought a Republican congressional baseball team practice under fire. Four men were wounded and the shooter was killed by Capitol Hill Police. The attack culminated six months of incendiary and, at times, seditious accusations hurled between the two political parties.

Unable to cogently argue opposing policy positions, antagonists have turned to ad hominem attacks. An ad hominem is an attack against a person rather than the position they are espousing. As Nassim Taleb has written, "An ad hominem attack ... indicates that the person does not have anything intelligent to say about your message." Flattering though they may be, ad hominem attacks are rending the fabric of our society.

Words are fruit and fertilizer. Anger and resentment fill the hearts of far too many people and their anger spews over as hateful speech. It matters little from which side of the political aisle this poisoned fruit comes. This destructive language is the fruit of the heart, but it also acts as fertilizer to the emotions that engendered the vile language. Giving voice to the hate only reinforces the emotion.

Unfortunately, the ugly fruit of the heart has resulted in more than intolerant language. Rotten fruit has created an atmosphere of crude language, despicable behavior, and violence.

Our Nation's heritage of free speech has been sullied by dishonest reporting and foul language. Comedians make the crudest of jokes and even portray the decapitated head of the President. Another 'jokes' about incest within the First

Family. An adaption of "Julius Caesar" shows a President look-alike being assassinated. Reactions from most opinion makers have ranged from muted criticism to praise.

Mask-clad bands of thugs have rioted and burned public property to intimidate speakers who disagree with their political beliefs. Such speakers have not been allowed to speak, and have been run out of auditoriums, and banned from appearing on universities.

As a people they have been lost to history and are known as the Ten Lost Tribes of Israel.

As a Nation, we should ask ourselves whether we have sown the wind and are now reaping the whirlwind.



ARMY ALMANAC AUGUST 2017 Milestones in Army History

- **185 Years Ago** 01 August 1832, **President Andrew Jackson** appoints **Lewis Class** as the fourteenth Secretary of War.
- **180 Years Ago** 05 august 1837, **First Lieutenant Robert E. Lee** arrives in St. Louis with the mission of improving the Mississippi River for boat traffic.
- **170 Years Ago** 20 August 1847, American forces led by **Major General Winfield Scott** inflict a resounding defeat on Mexican troops at Churubusco.

SBP-DIC Offset Rules

The way the rules are currently written, survivors of deceased military member and veterans who would be eligible for both Survivor Benefit Plan (SBP) and Dependency and Indemnity Compensation (DIC) benefits may not receive the full amount of both benefits. This is because of a rule called the SBP-DIC offset, under which SBP benefits are reduced by the amount of DIC benefits received. As a result, under the basic rule, the total SBP-DIC benefit received by survivors is no more than the larger of the SBP benefit or the DIC benefit.

While it is a simple rule on the surface, there are details that make the equation a little more complicated.

Tax Issues

First, DIC benefits are non-taxable, while SBP benefits are taxable. As a result, survivors who have their SBP payments offset by DIC payments do find that their net (take-home) benefits increase. The amount differs depending on the rest of the recipient's tax picture, but it is typically a few hundred dollars a month increase.

Refund of Premiums

Unless the death of the service member occurred on active duty, the military retiree paid into the SBP program. If, after the service member's death, it is determined that the survivor is eligible of DIC, the survivor will receive a prorated refund of the premiums that were paid into the SBP.

The Dumb Remarriage Rule

There is a weird twist to the remarriage rules for DIC. Generally speaking, you lose DIC benefits when you remarry. However, due to a weirdly worded law and subsequent court case, survivors who remarry after age 57 are eligible to retain their DIC benefits AND there is no offset applied.

A Temporary "Fix"

Through 2017, there is a temporary allowance called the Special Survivor Indemnity Allowance that provides additional cash benefits to survivors currently being impacted by the SBP-DIC offset. Currently, this allowance is \$310.00 monthly. While these rules are not popular, they have been the rules for a very long time. Many veterans groups spend a lot of time and money every year lobbying for these rules to be changed. Every year it seems possible, but it hasn't happened yet. In the meantime, you should be sure you understand the SBP-DIC offset rules so you can make informed decisions with your overall financial planning.



ALERT!! SENATE MAY RAISE TRI-CARE FEES

TRICARE enrollment fees, as well as other fees, most likely will get hit with hikes. DoD is looking for ways, in their words, to "plow savings back into readiness." Raising fees by repealing the grandfathering clause for TRICARE

fees contained in last year's law which shielded currently serving members from new fees, as is currently proposed by the DoD, is one way they aim to supplement readiness or other unspecified projects. These people never tire of trying to rob us or our benefits. "We do not think raising TRICARE fees through the repeal of last year's grandfathering, which is now law, is in any way fair to beneficiaries," says Capt. Kathy Beasley, USN (Ret), MOAA's Government Relations Director for Health Affairs. "The House saw fit to maintain the existing grandfathered fee structure and to maintain focus on the implementation of current TRICARE reform efforts. MOAA strongly agrees with the House." Now the Senate looks like it is going to repeal the House action. 10 things to know about the Veterans Choice Program

The Veterans Choice Program (VCP) is a benefit that allows eligible Veterans to receive health care from a community provider rather than waiting for a VA appointment or traveling to a VA facility.

1. Am I eligible for the Veterans Choice Program?

To be eligible for the program, you must be enrolled in VA health care and must also meet at least one of the following criteria:

- You are told by your local VA medical facility that you will need to wait more than 30 days for an appointment.
- You residence is more than a 40 mile driving distance from the closest VA medical facility with a full time primary care physician.
- You need to travel by air, boat, or ferry to the VA medical facility closet to your house.
- You face an unusual or excessive burden in traveling to the closest VA medical facility based on a geographic challenge, environmental factor, medical condition, or other specific clinical decisions. Staff at your local VA medical facility will work with you to determine if you are eligible for any of these reasons.

You reside in a State or a United States Territory without a fullservice VA medical facility that provides hospital care, emergency services and surgical care, and reside more than 20 miles from such a VA medical facility. Note: This criterion applies to Veterans residing in Alaska, Hawaii, New Hampshire, Guam, American Samoa, Commonwealth of the Northern Mariana Islands, and the U.S. Virgin Islands. Also note that some Veterans in New Hampshire reside within 20 miles of White River Junction VAMC and are therefore not eligible for the Veterans Choice Program.

2. What if I think I am eligible?

Call the VCP Call Center at 866-606-8198 or visit the Veterans Choice Program website to verify eligibility and set up an appointment here.



3. Can I call my non-VA doctor to make an appointment?

No, please call the VCP call center at 866-606-8198 to verify eligibility and set up an appointment.

4. How is the 40 mile calculation determined?

This calculation is based on the driving distance from your permanent residence (or active temporary address) to the closest VA facility, including Community-Based Outpatient Clinics and VA Medical Centers. You are eligible if you live more than 40 miles driving distance from the closest medical facility that has a full-time primary care physician.

5. If I am eligible for the Veterans Choice Program, can I receive Beneficiary Travel for travel to appointments with a VCP provider?

Yes, the Choice Act does provide funding to pay for travel to VCP providers for Veterans who are eligible for Beneficiary Travel. However, it did not provide any new Beneficiary Travel eligibility.

6. If I didn't get my Choice Card or I lost my Choice Card, what do I do?

You do not need your Choice Card to access the VCP. If you didn't receive a Choice Card or lost your Choice Card, simply call 866-606-8198 to find out if you are eligible and to make an appointment.

7. How do I get my prescription filled if I use the Veterans Choice Program?

The community provider you see through the VCP can issue a prescription for up to a 14 day supply of a national formulary drug. You may have the 14 day supply filled at any non-VA pharmacy of your choosing.

Prescriptions can be reimbursed through the Business Office/Non-VA Care Coordination Office at VA facilities. This reimbursement may take 30-45 days to process, and requires a copy of the prescription and the original receipt. Veterans cannot be reimbursed at the VA Pharmacy.

For prescriptions needed past 14 days, please follow standard procedures to fill a prescription at the VA pharmacy.

8. If I use the Veterans Choice Program, does that affect my VA health care?

No, not at all. You do not have to choose between the two. The VCP is here to make it easier to access the care you need. VA is building a high-performing integrated health care network to deliver the best of VA and the community. This integrated network will give Veterans more choices to access care and ensure care is delivered where and when you need it.

9. What is my responsibility for copayments to my other insurance?

Nothing. VA is now the primary coordinator of benefits for VCP, so you are only responsible for your VA copayment.

Your VA copayment will be determined by VA after the care is provided. VA copayments will be billed by VA after the appointment.

10. How does the new VCP extension law affect me?

Public Law 115-26, enacted April 19, 2017, made three key changes to help improve the VCP. The law removed the expiration date for the program, made VA primary coordinator of benefits for services provided to you, and it removed barriers with sharing necessary health information with community providers.


