

Rules:

- Entry fees are \$50 per team of 5 (or \$10 per team member) due with entry form.
- NO CLEATS - please wear proper athletic shoes. Gloves may be worn.
- NO SITTING - players must remain standing. Sitting may be grounds for elimination.
- Players may pull for only **one** team.
- The umpire will stand at the center of the rope and give all directions from there. The umpire may be assisted by two line judges on each side. First team to pull mid-rope marker 6 feet beyond midline is the winner. Judge’s decision is **final!**

RELEASE AND WAIVER OF LIABILITY

By signature, I attest that I am physically fit and sufficiently trained to participate in this event. I have full knowledge of the risk involved. The waiver shall remain valid and may not be unilaterally rescinded by the participant. This form is to be signed by participant or if participant is less than 18 years of age to be signed by the parent or legally responsible guardian.
