FIRE CHIEF'S REPORT

ECSO/Emergency Communications Center of Southern Oregon – We continue to experience ongoing issues with inconsistent radio communication. These are primarily due to narrow banding and reduced coverage, topographic shadows and the age of our P25 compliant radios. We are currently field testing APX7000 in problem areas to determine whether that would have an immediate impact. Funding options have not been identified for adding additional radio towers and system improvements. *Goal #1G: Fiscal Stability* Reporting: Chief Hanley

PERS/Public Employees Retirement System – SB 1068 has been referred to Ways and Means and the legislature has adjourned. The potential impact on the organization due to recalculation of pensionable benefits and final compensation and unanticipated retirements has not been determined. **Reporting:** Chief Hanley

Risk Management - Working with SDAO on significant exposure to litigation. Reporting: No Report

Labor Relations – Continued discussions with Local 2596 President Aaron Bustard regarding Fire District operations, roles and responsibilities and ongoing cooperative efforts between management and labor. Meetings with individual members of the organization are ongoing. *Goal #2E: Human Resources Reporting:* Chief Hanley

Fire Stations - HVAC repairs at Station 1. Goal #5A: Facilities - Fire Stations Reporting: Chief Hanley

Grants – Exploring opportunities to fund Zoll Auto Pulse Devices (uninterrupted CPR). AFG are expected to open in the Fall and SAFER Funding will be available early 2018. *Goal #1H: Fiscal Stability* Reporting: Chief Hanley

Strategic Planning: Evaluating the various strategies and initiatives outlined in the Strategic Plan and attempting to implement where possible. Reporting: Chief Hanley




