A Rapist Finds Freedom

On the 8th September, 2007 the District Secretary and I started off on a motorbike from my home to visit Malende Company church, 20 km away. After traveling for 8 km we ran out of fuel. We were forced to push the motorbike for 4 km up to Hanakambe, next village. The idea was to find some sort of transport there, then go in the nearby clinic, 7 km away, where we could find fuel. We found a lady who was a church member. She also had a motorbike, which she offered for us to use. We took her motorbike and proceeded to Malende.

When we arrived back from Malende, we found the lady at home with her children. She welcomed us and even gave us food to eat. After eating I asked her if she had any prayer request. She pointed at her children and said, "These are my children and as you can see there's no man in this house." I asked what had happened to her husband. She said the world had taken him away and that he was in prison in Livingstone. She began to narrate how her husband ended up in prison.

The name of her husband is Auditor Kalombwana. He never liked the church but his wife did. He came from a rich family which had a lot of cattle. He was a very cruel man to everybody. He had a habit of raping young girls.

In August 2006, he raped a young girl. The parents to the girl were angry and they reported him to the police. When he heard that the police were looking for him, he ran away. The police caught up with him. He tried to escape and in the process he grabbed a gun from one policeman and shot him dead. Because there were many policemen, they managed to



capture him. He was taken to Livingstone prison. There he was to appear in court.

The parents to the convict believe in "charms" and wanted to use these methods to have him released. They also sent a lot of money, but all in vain.

As I listened to the story, I was deeply touched. I got my Bible and shared a few words of encouragement. Afterwards I prayed that God should help the family, and then we left.

Two days later the same family called me. They needed prayers. The whole family of the husband-convict was there. I spoke to them about the goodness of God and told them that it was time for them to look up to God. I told them to throw away their charms and not to spend any more money. I shared Jeremiah 33:3 which says, "call unto me, and I will answer thee, and shew thee great and mighty things, which thou knowest not." It was a good service. I made an appeal and they all gave themselves to Christ. We knelt down and prayed. I asked God to deliver the man. Then I told them that I would call them every day at 2:00 p.m. to pray for the man.

Then came the trial date. When the man appeared in court for the final verdict he was acquitted by the Judge. He could not believe it. Everybody expected him to get a life sentence. He was told that the family and I had been praying for him. He was touched and said, "this can only be done by the power of God." He started praying and confessed his sins. Upon seeing this, the whole family made a total surrender to Christ Jesus and came to believe fully in God. The whole family is now attending church together. The man is a completely changed person, currently preparing for baptism. Praise God for His great mercies toward us.


