## **COMMITTEES**

- EXECUTIVE AND FINANCE: 2019/2020 proposed budget presented. Proposal that money be
  raised through sponsors for harness racing to cover increased costs. Will set at next meeting.
  Discussion held on presenting more details of how money spent for a given line item. This is
  doable. Will be tracking the boat storage fees and misc repairs from county budget more
  rigorously. Discussion held on requiring liability insurance from groups serving alcohol.
- ENTERTAINMENT: Wentzel carnival not contracted yet but have not said unavailable. Whiskey Belles and Best Practice not available as a band. Other bands to pursue were mentioned. Discussion that tractor pull costs will go up by \$500 due to increase in eliminator. Increase added to proposed budget. Other ideas of proposed future entertainment discussed. - PROMOTIONS & TECHNOLOGY: Holiday parade being held in Westfield Nov. 29<sup>th</sup>. Susanne will
  make cards about fair dates and stress looking for volunteers & sponsors. Matt & others will
  work on building float with signs about fair date for the parade on that Saturday. Someone
  needs to pull the float in the parade.
