## MEMBERSHIP—Wendy Wolfe

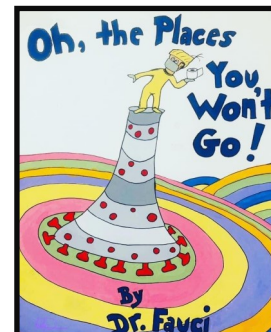
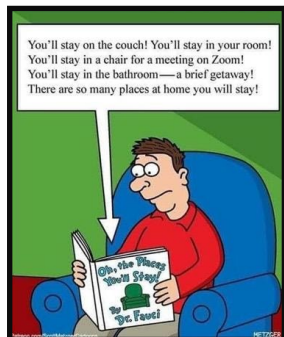
