SNOW EMERGENCY PARKING VS, ALTERNATE SIDE PARKING!

A snow emergency is AUTOMATICALLY

declared when a snow is forecasted to be 3" or more during any period of 24 hours or less. Under a snow emergency **ALL** vehicles must be **OFF** the streets until they have been plowed. We will enforce our ordinance 32-155. A snow emergency will take precedence over alternate side parking.

SNOW REMOVAL - USE OF ATV

It is unlawful to operate any minibike, go-kart, all-terrain vehicle or any other motor-driven craft or vehicle principally manufactured for off-highway use on the village streets, alleys, parks, parking lots, or on any public lands or private lands or parking lots held open to the public. The operator shall at all times have the consent of the owner before operation of such craft or vehicle on private lands. Sec. 32-13(c)(3).

Deposit of snow on streets or sidewalks.

No person shall deposit or cause to be deposited any snow or ice taken and removed from their premises or elsewhere upon any sidewalk, alley, parkway, public place or street in the village. Sec. 30-23(c).

Spring Primary election will be held on Tuesday, February 18, 2020. Polls will be open from 7 a.m. to 8 p.m. This election is a primary for the State Supreme Court Justice only.

Spring election and presidential preference primary will be Tuesday, April 7th. Candidates for Village Board are Michael Fischer (I); Michael J. Haynes (I) and Michael Babcock.

BUILDING PERMITS

Please call the office before starting ANY building project to see if a permit is needed. Permits are needed for fences, sheds over 150 sq. ft. (under 150 sq. ft. require a zoning app), plumbing, electrical work, new furnace, additions, structure changes etc. Permit fees will be doubled if you start a project without a permit.

Please allow 10 working days to obtain permit and fees are increasing for 2020.

LICENSE YOUR PET(S)

Dog and cat licenses are required annually per State Stats. and Village ordinance. You must bring in proof of rabies vaccination from your veterinarian's office (this must include date of vaccination, tag # and manufacturer of vaccine; not your receipt of services). Licenses are due by April 1, 2020 or a late fee will apply! Failure to license you pet could result in a fine of \$218.50.

License Fees: Spayed/neutered dog or cat \$5.00. Unaltered dog or cat \$10.00. You can drop off your rabies certificates with payment and a self-addressed stamped envelope and we will mail your tags if you cannot make it to the office during open hours.

GARBAGE/RECYCLING

Good news! The Village board made the decision to move to automated collection and the use of supplied garbage and recycling carts from Columbia County Solid Waste. This will take some time, so please be patient and watch for a mailing on this to come out soon!

In the meantime, please continue to follow current rules pertaining to collection and make sure items are out to the curb prior to 7 a.m. the day of collection.

OFF-STREET PARKING

Please reference section 58-190 of the village ordinance code regarding parking rules and regulations. Parking IS NOT PERMITTED in a front yard if not on a hard (paved or gravel) surface. Also, there are rules on trailer parking as to where it can be located in the yard and in relation to lot lines. Please make yourself aware of the rules and be conscientious of your neighbors when parking vehicles and trailers.

UTILITY CORNER

EXCITING NEWS!!

Residents can now make payments with credit cards in office!! This will be for the utility bill amount + \$2.99 fee per transaction ONLY. We CANNOT take a card for a re-connect fee, that amount will need to be paid with cash/check.

Utility bills are mailed on the last working day of the month and due the 20th (or next business day if a weekend.) It is your responsibility to keep your account information up to date!

If you do not receive your bill, please call Village Hall and we can get you a total or another copy. Failure to pay **by the due date** will result in a penalty and past due notice being generated.
