Short researched rates between \$10 to \$12.50 and deposit of \$15.00. City of Buffalo owned truck and did their own hauling for a while but it was not financially feasible. Less wear and tear on streets. Should save citizens money. Springfield looking into doing zoned areas.

Samantha Bowman acting as a citizen stated City of Willard does a preferred provider trash service.

Ault stated good idea but doesn't want to put anyone out of business.

Miller- it is wise not to put anybody out of business and customer service is a big issue. Does not like taking choice away from citizens.

Gourley stated he would be for it.
