Regular meeting call to order:

Salute to the Flag:

Public Participation:

Claudine Falger presented to the Supervisor a letter signed by 17 Washington Township residents with concerns of the need for "Watch Children" signage along Farmers Turnpike. As discussed the speed limit on Farmers Turnpike may be in need of reevaluation, due to the amount of homes built in that area over the course of several years. Farmers Turnpike is a state road, Roadmaster to contact the state for further information and possible remedies to the residents' concerns. A speed limit study may be required to change the "speed limit" on Farmers Turnpike; this would need to be requested from the township to Penn Dot.

John Barlick presented to the supervisors a new plan for a change in the alarm cards and seeking the approval of the supervisors. As discussed the alarm cards past and present and how the area is in need of better emergency services coverage, and how Act 7 influences the responsibility of townships to be more involved in emergency services.

The supervisors requested that the alarm card change be submitted to the governing board in written form and will be discussed at the regular October meeting.

Motion made by Jaime Hartline 2nd Leslie Devett to accept resolution 3-2009: EALA authorizing the agreement between the Pennsylvania Department of Transportation and Washington Township, Cambria County, Lilly, PA to use the dot grants on-line reporting Liquid Fuels forms annually. Roll call, All in favor, Motion passed.

Delinquent sanitation customer listing presented to the Supervisors, next step is to contact the Cresson Township Police Department to file at the local magistrates office.

Correspondence:

Duke Energies letter that the ownership of North Allegheny Wind Farm, LLC has been purchased by Duke Energy, and also to clarify the decommissioning letter of credit, that Duke Energy is solely responsible for decommissioning any and all wind turbines located in Washington Township.

Road Masters Report:

Road paving in the Township is completed paving and sealing, berming of the roads is being completed by the township employees. Roadmaster is satisfied with the paving and working with New Enterprise Stone & Lime.

Engineers Report:

As discussed the Franey and Pigza conveyance plan is more than a minor boundary line change, sewer line easement not shown on the sketches provided to the township, and other minor details that should be added, this land conveyance should be done as a simple subdivision, in accordance to the Washington Township Land Development Ordinance,
