CONSIGNMENT GUIDELINES

1. Nomination deadline is January 15, 2020
2. All cattle must be registered in the seller's name with either TLBAA or ITLA. Calves at side must be noted on the dam's Transfer Application.
3. Each lot will be comprised of either cow, or cow/calf pair.
  - a. Split lots will be charged an additional \$100 a head and the split must be registered and come with a completed and signed transfer.
4. Consignment Packages:
  - a. Any Female that is 100" Tip to Tip and under the age of 10 will be given a free consignment to the sale. Included in this package will be a single page consignment, featuring an extended pedigree along with additional pictures of offspring, service sires, or parentage. Also included will be 2 free full page ads that will be featured in the sale catalog. Sale commission will apply.
  - b. Any Female that is 90" Tip to Tip and under the age of 10 will be given a free consignment to the sale. Included in this package will be an extended pedigree along with a free full page color ad featured in the sale catalog. Sale commission will apply.
  - c. Any Heifer that is out of a 100" or 90" Tip to Tip female will be given a free consignment to the sale. Included in this package will be an extended pedigree along with a free full page color ad featured in the sale catalog. Sale commission will apply.
  - d. The consignment fee for all other nominations will be \$400 plus 12% sale commission. Any consignor that participates by purchasing a consignment featured in the sale will be given a 5% discount on the sale commission. Checks will be made out to:  
Lemley Auction Services.
  - e. Bidding will begin at \$1000. Failure to sell your animal will result in forfeiture of your consignment fee.

- f. PO's are seriously discouraged so we ask that if you need a certain amount for your consignment please give the auctioneer your reserve before the sale. No reserves will be accepted once the sale has started. Please keep reserves reasonable.
  - g. Scratched lots will be subject to forfeiture of the consignment fee. Substitutions will be permitted after the deadline; however the seller is responsible for providing certificate of registration, and transfer application prior to the sale. The seller is responsible for any handouts, pictures, and breeding information to be handed out day of sale.
5. All nominations must be accompanied with following:
- a. **Consignment Form.** Completed and signed.
  - b. **Consignment Fee:** Check made out to Lemley Auction Services. Unpaid consignment fees will be charged an additional 10% fee to be taken from proceeds at completion of the sale.
  - c. **Picture:** Please provide photos that will promote your consignment. We prefer email only (jpeg format only 800 x 600) Emails must be accompanied by name of cow and owner. Please no phone text or Facebook communications pictures.
  - d. **Certificate of Registration:** Please send the original certificate. No copies will be accepted. Registration must be in the seller's name. Failure to have proper or no certificate will result in a \$15 handling fee.
  - e. **Transfer Form:** Each transfer must be completely filled out along with calf at side and breeding information. Failure to have a proper or no transfer will result in a \$15 dollar handling fee.
  - f. **AI Certificate Form:** Females that are bred by artificial insemination must be accompanied by proper AI certificate signed by the technician.
  - g. **Embryo Transfer Form:** Any animal consigned that is by Embryo transfer must be registered and accompanied by a registry transfer form. Recips must have ET form signed by the technician.
6. All cattle must be tested for interstate shipment. Each consignment shall comply with applicable rules and regulations of the State of Kansas. Any animal over the age of 18 months must be tested for brucellosis not more than 30 prior to sale.
7. All animals 12 months of age and over are required to be tested negative for Tuberculosis not more than 30 days prior to the sale.

8. All females 12 months of age and over are required to be OCV (Official Calf Vaccination). Any animal that is consigned and NOT OCV compliant will be announced from the block as such and as required by the Kansas Animal Health Commission.
9. All females that are of breeding age must have a written pregnancy determination either by your veterinarian or by your serum test technician. Called exposure dates by consignors or "To Close to Call" proclamation will be determined OPEN. Animals will not be announced "Safe in Calf" with out professional documentation.
10. All health certificates must accompany animals at the time of unloading. Each MUST have its own certificate. No animal will be unloaded without a valid Health Certificate.
11. The Midwest Sale assumes no responsibility or liability for any guarantee made by the consignor. All guarantees are strictly between consignor and buyer. The Midwest Sale is not responsible for the health or safety of any animal consigned to the sale. This includes loss of life, loss of health, loss by theft or other perils.
12. The Midwest Sale will be offering a very competitive rate for advertising in the sale catalog. A full color ad will be \$300 which includes graphics and design. Inside front, inside back, and back covers will be \$500 which includes graphics and design. This is a great opportunity to expand the marketing of your consignments at a reasonable cost.
13. All consignors my comply with all of the above regulations, rules, and conditions stated by the Midwest Texas Longhorn Sale. A mandatory list of "Terms and Conditions" will be listed is the sale catalog. All sellers and buyers are required to comply as indicated by law.
14. Please use the check list to ensure all of the information and required documents are included in your consignment package. Please do not depend on emailed documents holding a place for your consignment in the sale. Please help us make your experience as smooth as possible. We look forward working with you to market your cattle and your program.
