Assistant Fire Chief Adams: Through the County EMA, Adams acquired a 2011 Ford 750 for FREE for the Township Fire Department! It came with a 30ft. trailer and a 5k generator. This is \$160,000.00 worth of equipment! It was mentioned how much we appreciate the hard work Adams does for the Township, especially when it comes to grants and things like this.

A motion was made by Horn to accept the transfer of the truck, trailer, and generator. Fleshman seconded.

There is also a grant for \$3,000.00 from the Marathon Oil Company to pay for the nozzle on Engine 193, acquired by Adams.

Resident Mike Blevins: asked if the Firemen were on duty while they were campaigning? Fire Chief Adams gave a strong response of NO! Adams stated that the fire trucks were out draining hydrants. Fireman were off duty that were campaigning.

Police Chief Byron Smith: At Block Watches, Smith is hearing more concerns about drug houses, and speeders. He mentioned how overtime may be a good solution. It will have 2 officers more, 1 day a week, per month. This would allow for more patrol in high speeding areas, and a better presence around drug houses, to help deter drug activity.

Motion was made by Fleshman to accept the reimbursement for overtime pay for Special Duty in the amount of \$2,000.00 for one month to see the effects it has in the Township. Horn seconded it. Vote was taken: Fleshman yes, Horn yes, Cook yes.
