# From The Board:

Every year, each home in Sugar Mill pays an Annual Maintenance Assessment. These funds go to maintain, repair, update and pay daily operating costs for all common areas of the HOA. The question arises every so often "Why do I need to pay the entire assessment – I never use the tennis courts, swimming pools, park or lake". The HOA Board is charged with managing the maintenance, repair, updating and daily operation of the common areas in a prudent economic manner while keeping our community in top shape and maintaining or improving homeowner values.

For individual homeowners to be able to only pay for those HOA services that they actually utilize, we would have to change the overall HOA by-laws to allow individual home owners to pay fees based on usage of HOA facilities. That would require a positive vote of 2/3 of all homeowners in Sugar Mill. To make that work, the HOA would then be forced to hire personnel to specifically monitor the usage of the pools, the tennis courts, and the parks and playgrounds on a daily basis. This would be very expensive and impossible to manage.

Last month, we pointed out the ordinances of the City of Sugar Land with regard to pet waste. It was the HOA Board's thinking that by publishing the regulations, each home owner would decide that since each of us pay our annual assessments, it is each of our responsibilities to treat all common areas the way we would treat our own property. This was obviously an incorrect chain of thought since we have received many comments on the proliferation of pet waste in the common green areas around our community. So let's just put it out there. If you are walking a dog (whether you own it or are just walking it for a friend or family member), it is your responsibility to pick up that dog's waste. The HOA Board does not need to have another expense of hiring a contractor to clean up the pet waste!

This ordinance does not only apply to private lawns, but also to HOA/City maintained areas. The enforcement is up to all of us. If you see a repeat offender and know where they live, please take the appropriate steps (sending a letter to the homeowner) to keep our green spaces clear of pet waste.

In recent months we have also addressed complaints about trash/recycling bins not being put away after trash pick up days, and there are fewer and fewer bins out in the street. A gentle reminder too that trash/recycle bins must be stored out of sight either in a garage or behind a gated area (approved by the ACC). Also, please remember that green waste should not be placed on the curb for pickup until 7PM Sunday. If you use a lawn service, please ask them to remove your green waste or to put the waste out of sight after they finish their service. On some streets in Sugar Mill, there may be 20 homes with green waste sitting on the curb for several days before it is picked up. This does not present an upscale image for Sugar Mill.

Lastly, in response to numerous inputs from residents at our annual HOA meeting on March 25, we will be holding a special meeting of the Landscape Committee on Thursday, May 15, in room 608 at Sugar Land First United Methodist Church at 7:00 PM. We will be discussing how we should handle the updating of the 50 + cul-de-sacs in Sugar Mill and other related landscaping issues. If you want to have an input on how the Board should proceed with these issues, it is imperative you attend the meeting.

It seems that the cold weather is finally behind us, and the grass is green again. We are looking forward to summer and the fun that accompanies outdoor activities. Walk, bike and have fun!

# Marion's Fishing Corner

The rigors of spring-

Largemouth bass are entering into a very physically demanding part of their life cycle. Getting through a successful spawn can be quite difficult on them. You need to remember that they have just endured a very long, harsh winter. A winter in which very little feeding activity has taken place, and they have been surviving for the last few months on a layer of "fat" that they built up last fall. So their nutrition levels are low as they enter into a rigorous reproduction cycle. Females are heavy with eggs and ready to go on nests. The smaller males are busy with the laborious task of fanning out these nesting areas to provide siltfree areas for the eggs to be deposited. They are also charged with the task of "bumping" the female's abdomen area to loosen the eggs and make depositing them easier.

Once the eggs have been laid, the around-theclock task of guarding the nest begins. The nest must be protected from an endless number of egg-eaters including bluegills, crawfish, and even other bass. Once the eggs hatch, the fry must be protected from those same predators until they are large enough to swim away and fend for themselves. This entire process can be very taxing on the adult bass, and we need to appreciate what they must endure. Research studies have confirmed that approximately onethird of the total population of mature bass in a



lake will not spawn on consecutive spring seasons. Some of the females will skip a year, even though they are mature, spawning age fish. Allowing the females to have a year off on occasion is nature's way of prolonging the life span of mature brood fish.

So please keep all this in mind when you catch your next bass. That fish has been through a lot and deserves it's freedom. Gently release it and be content to know that it will have the chance to spawn again next year.

Remember to catch and release, now more than ever.....

### **City Water Schedules**

Sugar Land has implemented Stage 1 voluntary water restrictions to comply with a request from Gov. Rick Perry to conserve water. A recent proclamation from Perry stated that exceptional drought conditions throughout the state pose an imminent threat to water supplies, including those in Fort Bend. Moderate drought conditions continue in Fort Bend County, and the drought conditions could continue or worsen with the approaching summer months when water demand is traditionally high. Sugar Land's Stage 1 water restrictions require voluntary conservation. Customers should limit irrigation to no more than two days a week and adhere to the City's voluntary irrigation zone schedule. The City's Irrigation Zone Schedule is divided into three categories: residential, commercial/industrial and roadway. Each category assigns specific irrigation days based on location within the City. The residential schedules are either Wednesday and Sunday or Tuesday and Saturday. Water is valuable; using it wisely is critical to water treatment and delivery operations. Water lawns only when needed; once every four days is ample. Turn-off irrigation systems when rain is predicted; leave them off until soil dries. Set lawn mower blades to cut grass 2-3 inches tall. Leave grass clippings on the lawn. Hand water landscape areas that require extra water. Irrigation zone schedules and more water saving tips can be found at: www.sugarlandtx.gov/sugar-

## Police Department's Annual Report

Part 1 crimes in Sugar Land increased 3.6 percent last year while the City's five-year trend shows an overall decrease of more than 18.5 percent. The results were included in the Sugar Land Police Department's 2013 Annual Report. Part 1 crimes include assault, auto theft, burglary, homicide, theft, robbery and auto burglary. The most recent Part 1 data shows Sugar Land's overall crime rate is 40 percent below the state and national averages. The City's violent crime rate compares even better at more than 205 percent below the state and national averages. Sugar Land's violent crime rate dropped 9.4 percent last year and has declined more than 16.6 percent since 2009. The crime data recently contributed to Sugar Land's selection by CO Press as the third safest city in Texas and the 19th safest city in the nation, a distinction based on an analysis of FBI crime statistics. Nonviolent property crimes, mostly vehicle burglaries and shoplifting thefts, are largely responsible for last year's increase in Part 1 crimes. These crimes increased 4.7 percent, though the City's fiveyear trend shows an overall decrease of 18.3 percent. The largest increase last year was vehicle burglaries at 30 percent. 
