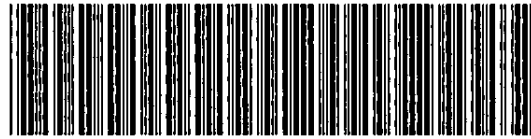

**FOR**

The undersigned, acting as Incorporator of a corporation pursuant to chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

**ARTICLE I  
NAME**

The name of the corporation shall be **CROSS & ANVIL HUMAN SERVICES, INC.**

**ARTICLE II  
PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS**

The principal place of business and the mailing address of this corporation shall be 1045 16<sup>th</sup> Street South, St. Petersburg, Florida 33705.

**ARTICLE III  
PURPOSE**

The purposes for which the Corporation is formed and the objects to be carried on and promoted by it are as follows:
