TITLE: COVID-19 PUBLIC HEALTH EMERGENCY FAMILY ASSISTANCE PROGRAM

- WHEREAS, the Summit Lake Paiute Tribe is organized pursuant to Section 16 of Indian Reorganization Act of June 18, 1934 (48 Stat. 984) as amended, with the Articles of Association, and approved by the Secretary of the Interior on January 08, 1965, granting certain powers of the Summit Lake Paiute Council (see Article II, Section 1); and
- WHEREAS, the Summit Lake Paiute Council has the power and duty to represent the Summit Lake Paiute Tribe in negotiations with Federal Governments in matters to benefit the general welfare of its tribal membership; and
- WHEREAS, the Summit Lake Paiute Council is the duly constituted governing body within the boundaries of the Summit Lake Paiute reservation; and
- WHEREAS, the Council solicited input from tribal membership regarding the needs of the membership due to the global pandemic related to the Corona virus; and
- WHEREAS, the Council reviewed the many comments received from tribal members of urgent needs caused by COVID-19 at a Special Council meeting held June 6, 2020; and
- WHEREAS, The Council hereby declares to establish the COVID-19 Public Health Emergency Family Assistance Program as a grant program for adult tribal members 18 years of age or over as of June 6<sup>th</sup>, 2020 to distribute the CARES Act funding received for eligible expenses as outlined in the Grant application; and

**NOW THEREFORE BE IT RESOLVED**, that the Summit Lake Paiute Council hereby declares that funding up to the amount of \$500.00 for enrolled adult Tribal Members age 18 or over as of June 6<sup>th</sup>, 2020 will be distributed upon receipt of a completed Public Health Emergency Family Assistance Program application.
