

8/13/2018

Deputy Copley responded to a theft in the Sardis area. Investigation pending.

Deputy Ridley responded to a crash on State Route 145. Crash report taken, no injuries reported.

Deputy Copley responded to an animal complaint in Clarington. Investigation pending.

The Monroe County Sheriff's Office received a report of a roll over accident on County Road 43. Post 7 responded to the crash.

Deputy Ridley responded to as court order escort to obtain personal property. Possessions were taken peacefully.
