Exhibitor Information

Dogs may enter both the Instinct Test and Novice class in the same trial until the dog has earned the RATN title. Dogs completing a title on Saturday or Sunday trial 1 may move up for Trial 2, Saturday or Sunday. If title completed on Saturday, move ups allowed for Sunday. Move-ups between trials need to be done as soon as the class is over and until ½ hour after the conclusion of the Trial for move-ups between days. Move-up forms will be available at the Secretary's table. All entries must be accompanied by entry fees to be valid. A returned check does not constitute a valid entry. There will be a \$35 fee for all returned checks. No entries will be taken over the phone or electronically. Make check payable to CATC. Send entries & fees to the trial secretary. Dogs must have a Barn Hunt registration number.

Electronic collars and/or devices or flexi leads are not allowed in the building. Approved collars include flat snap or buckle of solid construction and leather or nylon leads. Limited slip martingale and single piece slip collars/leads are allowed. Harnesses are allowed.

Dogs should be brought to the ring with collars/harnesses which can be easily and quickly removed and replaced. Dogs may **NOT** be brought to the gate in any disallowed collars, prong collars, or on a Flexi lead. Dogs **MUST** run "naked", i.e. without collar/harness.

Dogs will be run in height order from Small to Large with dogs being handled by the same person separated into differently staged groups.

Refunds are available for injured, deceased dogs with veterinarian note.

Bitches in season are eligible for entry but will be required to be kept separate from all other dogs and will be run at the end of their class. Bitches in season are required to run in panties and remain in panties unless outside in the separate potty area. If bringing a bitch in season, you must inform the trial secretary prior to the trial and inform all exhibitors at the judge's briefing.

BARN HUNT AGREEMENT

I (we) acknowledge that if this application for the entry of this dog is made available to me (us) for participation in a Barn Hunt event, that I (we) agree that this facility has the right to refuse the entry of this dog and/or they reserve the right to dismiss the dog and myself for cause which Barn Hunt deems to be sufficient. In consideration of the acceptance of this and the opportunity to train my dog(s), I (we) agree to hold Barn Hunt Association, LLC, Columbus All-Breed Training Club, and all associates harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog or dogs while in or upon the premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for such claim, and I (we) further agree to hold the aforementioned parties harmless from any claim for damage or injury to the dog or myself, either physically or mentally, whether such loss, disappearance, theft, damage or injury, be caused or alleged to be caused by negligence while in or upon the premises of the Barn Hunt grounds. The terms of this agreement bind the parties for the current period of training, and all subsequent classes/training/events in which they hereafter participate.

Columbus All-Breed Training Club Liability Waiver Agreement

I (we) agree that the club holding this event has the right to refuse entry for cause which the club shall deem sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold Barn Hunt Association, LLC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any Barn Hunt approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance there- to, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend, and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other persons.

From the South

Take I-71 N towards COLUMBUS Take the I-270 exit, EXIT 101, toward WHEELING/DAYTON. Merge onto I-270 E via EXIT 101B toward WHEELING. Take the ALUM CREEK DR exit, EXIT 49, toward OBETZ. Turn LEFT onto ALUM CREEK DR. Turn LEFT onto E WILLIAMS RD. 2164 WILLIAMS RD is on the RIGHT.

From the East
