Running Order and Class Information

Please check all your trial information carefully on the confirmation you were sent and notify me immediately in writing with any corrections. You can contact me via email at LKSAGE@aol.com or by phone (503) 840-4303 (cell), email preferred.

SITE INFO: This trial will be held in two rings indoors on packed dirt. Crating is on concrete around the periphery of the rings.

ENTERING THE SHOW GROUNDS ON THURSDAY:

The Clark College Graduation has been scheduled for Thursday, June 21st at the Amphitheater, which will affect people coming into camp. No one will be able to enter or leave the grounds from 3:00pm-8:30pm on Thursday, June 21st. All gates, including Purple Gate will be locked at 3:00pm and only emergency exit will be allowed through the loading dock gate during these hours. The club has permission for those coming to help unload to exit afterwards through the loading dock. We will be unloading at 2:00pm. Therefore, if you are camping and plan to arrive on Thursday you will want to arrive prior to 3:00pm or after 8:30pm. Sorry for any inconvenience this may cause.

DIRECTIONS TO THE TRIAL SITE:

From I-5: Take EXIT 9 (in Washington), head West on 179th Ave. for ½ mile, turn left onto 2nd Ave., then turn left again at the Purple Gate. Exposition and Equestrian Bldg. is on the right, at the end of the road. Feel free to park in any marked parking spot around the arena building. Please do not block any arena entrance or access road.

MEASURING: We will have a VMO on site so all dogs without height cards will have to be measured, including the 24 & 24C" dogs. Handlers whose dogs need to be measured will not be able to get their armbands until they are measured. We will have a VMO available to measure dogs throughout the day near the trial secretary's table. It is your responsibility to have your dog measured BEFORE you run.

GENERAL: ALL dogs are required to be kept on leash at ALL times. And please pick up after your dogs.

VOLUNTEERS: We will be using the white board for sign-ups. If you can, please volunteer for the class(es) that you can help with. CRAC will issue raffle tickets to each worker to be used in a DAILY workers raffle which will have many wonderful items and services. The workers raffle will be drawn each day in the early afternoon. There will be a special raffle draw which will occur daily for those volunteering as chute setters or leash runners. Prizes must be claimed by the conclusion of the trial on Sunday.

CONFLICTS: We will do our best to accommodate conflicts. If you have a conflict, Standard takes precedence over FAST and JWW. Put a "C" instead of a check mark on both gate sheets so the scribe and gate stewards will know you have a conflict.

MOVE-UPS: The deadline for move-ups is Monday, June 18, 2018 at 6 pm and must be submitted in writing (email ok). Day-to-Day move-ups will be permitted at these trials and must be submitted to the score table no later than 30 minutes after the end of the trial.

ALL FAST CLASSES WILL WALK TOGETHER AND RUN TOGETHER BY JUMP HEIGHT.

Walk through groups may be changed at the trial to accommodate for workers.
