- 1. Commissioner Huber called the Bexar County ESD 4 Meeting to Order at 7:02 P.M. and established a quorum. Commissioners Rasmussen and Roberts attended via phone.
- 2. Citizen Public Forum. No citizens chose to speak.
- 3. Approval of the minutes from the April 6, 2020. Commissioner Surratt motioned to approve the April 6, 2020 Meeting Minutes. Commissioner Roberts seconded the motion. Motion carried by a 4/0 vote in favor of.
