Landfills are available to Hankinson residents only or contractors working within city limits of Hankinson. City of Hankinson personnel must be present. Anyone caught dumping items without permission will be subject to a fine up to \$500. The City of Hankinson reserves the right to reject or refuse unlawful materials.

WEST INERT LANDFILL

OPEN: 4-8 pm Wednesday; 8-12 and 1-4 pm Saturdays

Mid-May thru freeze-up WEATHER PERMITTING

Recycled Compost is available to city residents at no cost

ITEMS PERMITTED: GRASS & LEAVES

TREES. NO Stumps, must be less than 16" in diameter & 10' in length

WOOD. NO Treated Lumber. Treated Lumber must be taken to North Landfill. Pallets must be stacked

ITEMS NOT PERMITTED: Household Waste,

Municipal, Industrial, Commercial or Infectious Waste, NO Pesticide Containers, Asbestos, Paint, Oil Filters or Hazardous Waste, Tires, TVs, Computers, Microwaves

NORTH LANDFILL

OPEN: by Appointment ONLY - Normal Business Hours Mon-Fri

Weekends and After Shop Hours WILL BE Charged Additional Fees

ALL FEES MUST BE PAID before access to Landfill

N/C Fill Materials - Rocks, Dirt & Gravel

\$10.00 Minimum Fee This includes a pickup box load or small trailer

\$10.00 Cement / Asphalt

\$25.00 Single Axle Dump Truck/Trailer

\$50.00 Tandem Axle Dump Truck

\$50.00 Shingles per Load

\$80.00 Semi Load or Dumpster

Building Demolition will be charged by Sq Ft.

\$ 0.30 Single Story Structure

\$ 0.40 1-1/2 Story Structure

\$ 0.55 2 Story Structure

All building demolition must be pushed in by bulldozer following completion of project.

Any building debris being pushed in by City of Hankinson will be charged an hourly fee of \$100/hr.

\$30/hr After Hour & Weekend Fee with a **minimum fee of \$25**

ITEMS ACCEPTED: Carpet, Mattresses, Furniture, Flooring, Sheetrock, Shingles, Building Demolition Debris, Concrete, Fill Material, Asphalt

NO Household Waste will be accepted. Any loads with additional waste including pop/water bottles, newspapers & light cardboard will be charged an additional fee of \$15/load

ASBESTOS

All North Dakota State Dept. of Health rules and laws must be followed. A proof of asbestos inspection must be provided BEFORE demolition material may be hauled into the landfill. A State of ND Asbestos Variance must be obtained before any demolition material that contains asbestos may be hauled into the landfill.
