Please forward to those on your distribution lists at your earliest convenience. The 45-day window in which we can make comments on the Environmental Assessment's findings started to run yesterday.

Yesterday the FAA released its Environmental Assessment report thus starting the 45 day comment period that runs from April 22<sup>nd</sup> through June 6th. The report can be accessed through the below site under Documents (found at the upper left of the page).

The Environmental Assessment is long and technical. As we had suspected, it came out with an apparent **finding of no significant environmental impact**. The report also provides page after page of support for the implementation of NextGen over the Front Range.

Of note, when you open Documents, there is also a Media release from 2017 (not 2019). Of particular interest is what the FAA states at the end of the second to last paragraph.

Please read both the Environmental Assessment, or at least the various summaries set out in it, and the Media Release.

We need to make certain that we have as many people as possible send comments to the FAA on the Environmental Assessment's findings (Comments tab is also on the below website, upper left of the page) and attend the "workshops" that the FAA is holding. See the schedule of times, dates and locations below.

It is imperative, for the our wellbeing and health, the environment (pollution and noise) and our property values, that NextGen Denver is never implemented. We need everyone support to make this happen.
