**3. Approval of February Minutes**

**4. City Budget Discussion – Lauri Vickers**

- Lauri presented the three-year average of city revenue, along with a discussion of city funds.
- The city is \$8.2 million above the revised revenue; however, overall, Tempe is down compared with last year.
