



**Request for Automotive Services and/or Repair by
Amphitheater Public Schools
Automotive Technology Programs**

General Conditions/Waiver of Liability

I, the undersigned, confirm that I am the lawful owner of the vehicle described in the repair order referenced below, and I do hereby grant to the faculty, staff and/or students of Amphitheater Public Schools' Automotive Technologies programs at Amphitheater High School or Canyon Del Oro High School ("the Auto Program") who are selected to perform repairs on my vehicle permission to operate and to inspect my vehicle and to undertake and complete the work described in the repair order.

In granting this permission to inspect, operate and work on my vehicle, I acknowledge that I have read, understand and agree to the following General Conditions:

- (1) The services or work I have requested the Auto Program to perform on my vehicle will not be performed by trained or professional service technicians. Rather, by the very nature of the Auto Program, the work will be performed by high school students who are receiving training and instruction in automotive technologies. Because services will be performed by students in training, the Auto Program will not charge for labor services performed. Any and all parts and materials required to complete the services or repairs described in the repair order shall be furnished by the undersigned owner of the vehicle. The Auto Program may charge, and I agree to pay for, any incidental costs incurred by the Auto Program in providing service or repairs to my vehicle.

- (2) Because the Auto Program must ensure students learn a broad spectrum of automotive technologies curriculum and content, the time students may be able to work on my vehicle may vary. Therefore, a time frame within which repairs and work will be completed cannot be guaranteed.

- (3) While Auto Program students will make every effort to perform their highest quality of work, Amphitheater Public Schools, its Governing Board, employees, teachers, instructors, agents, and students in no way guarantee the quality, longevity or efficacy of the repair or other work undertaken pursuant to this request. The services provided

by the Auto Program are provided without any warranty, whether express or implied. Warranties on parts, if any, are only those provided by the manufacturer.

- (4) Amphitheater Public Schools, its Governing Board, employees, teachers, instructors, and agents, assume no liability for damages to the undersigned's vehicle caused by fire, theft, collision, equipment malfunction or vandalism while the vehicle is being repaired, serviced, stored, or operated by the Auto Program.

- (5) On completion of repairs or upon request by the Auto Program, the vehicle must be removed from the Auto Program premises within (10) business days after notification; otherwise, the vehicle will be towed away at the undersigned owner's expense.

In consideration for the Auto Program performing the services described on the repair order, I hereby agree, on behalf of myself, my successors, heirs and assigns, to hold harmless and forever release, acquit, discharge and covenant not to sue Amphitheater Unified School District (d.b.a., Amphitheater Public Schools), its governing board, officers, employees, agents, representatives and/or students ("Released Parties") from any and all claims (direct or derivative), actions, causes of actions, demands, rights, damages, loss of services, expenses, or other cause of action of any nature whatsoever, which the undersigned may now have or which may hereinafter accrue to the undersigned on account of, or in any way arising out of or in connection with the undersigned's request for automotive services and/or repair, including but not limited to any and all known or unknown, foreseen and unforeseen injuries and/or damages and the consequences thereof, including but not limited to personal injury, property damage and wrongful death, whether or not such injury, damage or death is caused in whole or in part by the negligence of the Released Parties.
