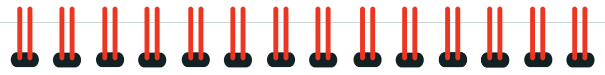

FENN REA will be holding the Annual General Meeting (AGM) as follows:

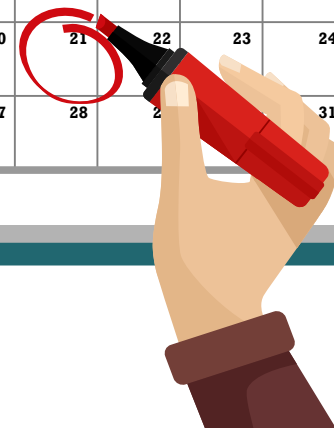
Date: Monday, March 21, 2022

It's Important to Keep Member Contact Information Up-to-date

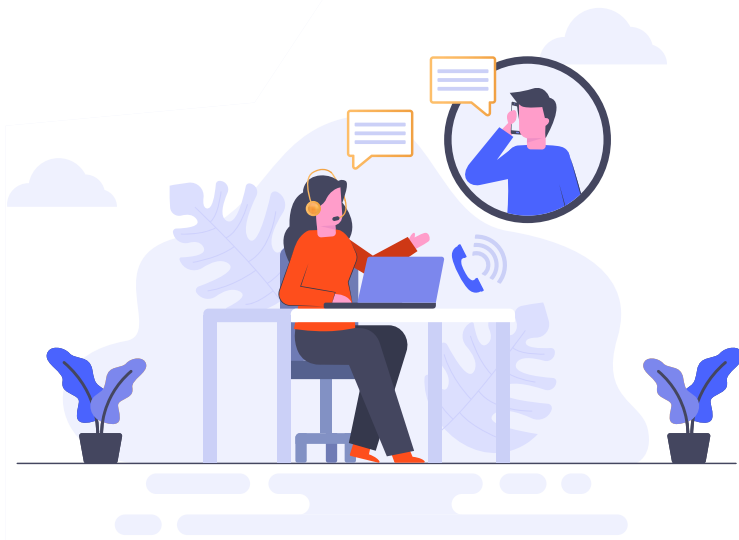
As we move into year 2022, we ask all members to ensure that FENN REA and our Regulated Rate provider, Battle River Power Coop, has your most current information on file.

Tips for Safer Winter Driving

Traction: A bag of sand, salt, or even kitty litter can make all the difference when you just need a little more grip under the drive wheels to get moving again.

When trying to free a stuck vehicle, remember to keep the wheels pointed straight ahead wherever possible. When starting to move try to limit wheel spin, which simply digs the vehicle in deeper.

Power: Keep a charged jumper-pack in your ride and consider opting for a model that can be recharged by plugging into the 12-volt outlet in your vehicle. Use it as needed to recharge a cell phone or boost a dead battery.

If you boost your battery to restart a vehicle be sure to let the engine run for a good long time to recharge the battery and don't turn the engine off until you're in a safe location.

Visibility: As a driver, seeing and being seen are key for winter driving safety. If you become stranded or immobile, make your surroundings as visible as possible by keeping a flashlight, road flares, battery-powered SOS light and a reflective vest in your ride, as a bare minimum. Remember to immediately engage your hazard lights after a collision or accident, even if you're off the road.

Warmth: Hot packs, a parka, candles, heavy gloves and warm footwear, as well as a thin foil thermal blanket can all make a big difference when it comes to keeping warm in extreme cold.

If you're stranded inside of a vehicle, and the engine is still able to run, remember to only run it a few minutes every hour. Be sure to keep the exhaust pipe(s) clear of snow and ice to prevent the buildup of dangerous gasses inside the vehicle.

Regulated Rate Option (RRO)

The RRO rate may increase or decrease from month to month as it is priced on the open market and subject to many factors relating to supply and demand. If you do not have a contract with an electricity retailer, then you receive the default RRO rate.

For January 2022, the RRO is priced at \$0.16280 per kWh, which is reflected on your enclosed bill. For February 2022, the Battle River Power Coop monthly RRO billing rate for FENN REA members is \$0.14594. The RRO rate is also listed on www.fennrea.com.
