BYLAW NO. 9/2010

A BYLAW TO PROVIDE FOR ENTERING INTO AN AGREEMENT WITH OTHER MUNICIPALITIES, FOR THE PURPOSE OF ESTABLISHING REGIONAL FIRE DEPARTMENT #2 FOR THE PROVISION OF FIRE PROTECTION SERVICES

The Council for the Rural Municipality No. 496, in the Province of Saskatchewan hereby enacts as follows:

1. The RM of Spiritwood #496 is hereby authorized to enter into an agreement, attached hereto and forming part of this bylaw, and identified as listed below with the following municipalities, for the purpose of establishing Regional Fire Department #2 for the provision of fire protection services.

- 3. The RM of Spiritwood #496 will provide the administration for Fire Department #2, as well as use of the shop at Shell Lake located at NE 03-50-085-W3 to house their equipment and supplies. The administration office is located at 218 Main Street, Box 340, Spiritwood, Sask. S0J 2M0. The Village of Shell Lake will provide the volunteer firefighters, which will be appointed annually by the RM of Spiritwood #496 Council. Regional Fire Department #2 will be responsible for providing the equipment, supplies as well as all operating costs.
- 4. Representatives will be appointed by each authority to Regional Fire Department #2. Levies will be set by the appointed representatives and imposed to all parties to this agreement.
- 5. Regional Fire Department #2 will be responsible for its own budget, assets, liabilities, allocation of grants and the disbursement of surplus funds and reserves.
- Property insurance and liability insurance will be administered through the RM of Spiritwood #496 SARM insurance plan.

Memorandum of Agreement Between:

Regional Fire Department #2 And The Resort Village of Echo Bay

This Agreement Witnesses as Follows:

1. WHEREAS the Regional Fire Department #2 has been established and maintains fire department #2 for the provision of fire protection services to residents within the corporate boundaries of the Resort Village of Echo Bay;

AND WHEREAS the Regional Fire Department #2 is prepared to provide fire protection services, as hereinafter set out, to the Resort Village of Echo Bay;

AND WHEREAS the Resort Village of Echo Bay is desirous of the Regional Fire Department #2 providing fire protection services to all residents within the corporate boundaries of the Resort Village of Echo Bay.

- 2. Fire protection will be made available with the provision that the municipal authority whose ratepayers are provided fire protection services will collect the bill from the ratepayer, thus insuring that Regional Fire Department #2 is paid for fire calls.
- 3. It is understood and agreed that this agreement shall commence on August 10th, 2010 and be continuous. This agreement may be terminated by either party to the agreement in writing.
