Attached you will find the 2023 Pool Information Packet.

All residents/tenants <u>must</u> complete the 2023 application. Pool passes **will not** be validated or issued without a completed application.

Landlords/property managers must complete the tenant declaration form in order for tenants to obtain pool passes (separate forms are mailed to the landlord/property manager).

If you have pool passes from last year, do not mail them in, you may bring them to the shed at the pool with a completed application. If you sent them to us last season (2022), but did not pick them up, we still have them. Please complete the 2023 application and present it when you pick up your passes. Should you decide to wait to pick them up from the lifeguards when the pool opens, a completed 2023 application will still be required.

Included with this packet is a schedule of dates when you can **drop off** a completed application for your passes to be validated. Passes **will not** be processed or validated at that time, nor will they be mailed back to you. All dropped off applications and passes will be available for pick up on pool pass validation dates and times or may be obtained at the lifeguard station when the pool is open.

For those who have never had a pass, or lost your pass, you will need to provide a photo (**1**" **square**) or email a digital photo with a completed application to the address listed below. Currently, we are unable to take photos for the 2023 season.

POOL RULES AND REGULATIONS

The Holleybrooke Homeowners' Association, Inc. Resident adhere to and enforces all general rules and guidelines set forth by the American Red Cross.

- 1. No diving
- 2. No running
- 3. No glass containers
- 4. Smoking or vaping is prohibited within 25 ft. of the pool perimeter.
- 5. The use of drugs and alcohol is always prohibited.
- 6. The use of vulgarity is always prohibited.
- 7. The use of floatation devices, including pool noodles, are not permitted in the deep end of the pool.
- 8. All children (under 12) must be supervised by a parent or adult over the age of 18.
- 9. Any child using inflatable armbands must be supervised one-on-one with an adult who is in the water and within an arm's length of child.
- 10. For a child using a personal floatation device (PFD) that is **Coast Guard** approved and with a leg strap, only that child will be allowed outside arm's length but still must have adult supervision at least sitting on the side/edge of the pool with their feet in the water.
- 11. The maximum size for floatation devices is 30 inches.
- 12. Squirt guns are prohibited.
- 13. The use of the wading pool is for children 5 and under. Any child using the wading pool must always be accompanied by a parent or adult over the age of 18.
- 14. **Cloth and standard disposable diapers** are prohibited for use at the community pool. All non-potty-trained children must wear diapers or the "special" disposable swim diapers.
- 15. The lifeguards have permission from the Board of Directors to enforce any rule or safety issue that may arise regardless of whether it is a printed rule or not.

(This list is the "highlighted" rules, a complete list of all the rules is available from the lifeguards and on the HHOA website.)

***Please note that the grounds and facilities are monitored by video surveillance. Security cameras and recording equipment are always in use. ***
