## **KANSAS**

The geographic area that is now Kansas witnessed a number of political jurisdictional changes prior to its establishment as a distinct territory in 1854, that epitomized the fissure between North and South that led ultimately to the Civil War in 1861, the year Kansas entered the Union.<sup>2</sup>

Controversy dogged the court in the 1920s as well. Under the Act of February 25, 1919,<sup>3</sup> if a judge becomes disabled and unable to discharge satisfactorily the obligations of the office (yet chooses to remain on the bench), then Congress can create a temporary position to help the court dispose of its caseload.<sup>4</sup> The first vacancy to occur in either position will not be filled. In an ironic twist, Judge John Pollock used the legislation to his advantage. He was the sole Kansas judge and came under intense pressure from newspapers due to a large backlog of cases. Being seventy years old, he actually petitioned President Coolidge to certify him as disabled due to the infirmities of age so the court could get a second judge. Such was the genesis of KS.ST.02, to which Judge McDermott was appointed.<sup>5</sup> Upon Pollock's death in 1937, the ongoing line was effectively transferred to KS.ST.02. Another temporary position was authorized in 1945 (KS.ST.03),<sup>6</sup> with the provision that the first vacancy occurring on either KS.ST.02 or KS.ST.03 would go unfilled. This happened in 1946 when Judge Helvering died while in office, thereby ending the succession line of KS.ST.02.

KS.ST.06 also was created as a temporary position in 1966, but was converted to permanent in 1970. KS.ST.08, likewise created as a temporary judgeship, was renewed (but not converted to permanent) five years later. 8

Originally a member of the Eighth Circuit, Kansas was transferred to the new Tenth in 1929.9 It remains a single-district state, and has five regular and one temporary district court positions.
