MEET THE DETACHMENT LEADERSHIP DEAN MILES, QUARTERMASTER

It happened in July of 1982, Fort Knox, KY, I was a brand-new Marine Corps Tanker, fresh out of bootcamp, learning the methods and madness that define the Marine Corps Tanker and for those of you taking notes, the tank was the M60A-1 also known as the dinosaur.

On this particular night, we were conducting live fire exercises on the gunnery range, night fire training. I was in the gunner seat (YEEHAW), ready to blow some shi-stuff up!! Now before I continue the story, it's important here that I explain a very important piece of equipment at the gunners disposal, I forget the actual name of the Item, but I remember all too well what its function is, you see, when the tank commander yells out a fire command, part of that command contains what type of round you are to use, armor piercing sabot, high explosive plastic, heat, or anti-personnel. The gunner's job once he hears the ammo to be used is to reach over

to his right and dial in the ammo to be used into this device and this device then will tell the brains of the tank to adjust the main gun elevation accordingly. Each round flies a different trajectory, for example, an anti-personnel round is a lobbing round that arches to its target, exploding in the air above the target, whereas an armor piercing sabot round is a straight shooter, with a pretty much straight line trajectory, directly to its target, thankfully for me on this particular evening, this round does not explode, it is solid and is designed to punch a hole through the side of a tank at an extremely high velocity creating an extreme vacuum within the tank, delivering devastating and usually deadly results to the crewmembers within. So, as you can see, there is quite a need for this nifty gun elevating device. Now, each round listed in this device is represented with abbreviations, for example, anti-personnel round is abbreviated as "APERS" and the armor piercing sabot round is "APSR", so, in my defense here, I will just say that in low light conditions and in a hurry to complete the fire sequence, these two abbreviations appear almost identical.

So, the command comes down from the TC, Gunner (that's me), Sabot (the round), tank (the target) 280 degrees (the azimuth) 2500 meters (distance to target), it sounded like this,

"Gunner, sabot, tank, 280 degrees, 2500 meters!!", now, a whole lot is going on simultaneously while the TC is issuing his command, the loader grabs the round and loads it into the breach and yells "UP" indicating the round is loaded and ready to fire. The gunner (in this case, me) selects the ammo type in the computer and then peers through the scope to locate the target, once located, I yell, "IDENTIFIED". Here is where I made a tragic error, when I selected the ammo type in the computer, I selected APERS (the lobbing round) instead of APSR (the straight shooter sabot round) elevating the main gun to a lobbing angle, this was bad. The TC yells "FIRE!!!" still peering through the scope I fired the round. Not seeing the usual tracer signature in my sight, I yelled "LOST!" meaning, I could not see where the round went, almost immediately I'm feeling the boot of my TC in the back of my head as he was screaming some very colorful, descriptive as well as hurtful drunken sailor style personal pronouns directed at me. It appeared that the sabot round I fired went well above the mountain elevated tree line downrange and disappeared somewhere towards Louisville way, never to be seen again, oops.

Luckily for me and as far as I know, the fine city of Louisville never tried to return the gift, I was never court martialled and no distilleries were damaged. Good learning experience.....


