#### Working in the Woods? Watch out for Ticks!

Unfortunately, ticks and woods kind of go together, but not in a nice way like apple pie and ice cream. Since our property is pretty dry, we don't see many ticks, but we recently found an attached tick on each of us. Mike had a deer tick attached to his upper arm in May. Deer ticks, also called blacklegged ticks, carry the bacteria that causes Lyme disease, as well as other nasty pathogens.

We carefully removed the tick with tweezers by slowly pulling it out and placing it in a plastic bag. Then we applied rubbing alcohol to the bite. A few mouthparts remained, but they eventually disappeared. We placed the tick in a small, sealed bag and sent it to the tick lab for a free identification and pathogen test – see next page for more details about the tick lab. We included a paper with personal information and included our cell phone number and email since we'd get the results faster. A few days later, the lab texted it was a deer tick, but it hadn't started feeding yet. Good news! Another few days of waiting and we got an email saying that no pathogens were detected. The lab states it has a 99.9\$ accuracy rate. Yea!!

In early summer I found a larger tick on my neck, removed it with tweezers, and sent it to the lab. This tick was an adult female American dog tick. Dog ticks don't carry the pathogen that causes Lyme disease, but they do carry the Rocky Mountain spotted fever pathogen and other nasties. Like Mike's tick, the dog tick had not yet started feeding. A few days later I received the good news that the dog tick did not test positive for any pathogens!

Don't forget to do a tick check every day on yourself, kids, and pets!!

## TICK TESTING

The Centers for Disease Control estimates that approximately 100,000 Pennsylvanians will contract Lyme disease from tick bites. Also, according to the CDC, the states with the highest number of cases are Pennsylvania, New Jersey, and New York. Lyme disease and/or other rickettsial infections can be mild to debilitating.


The **Tick Research Lab of Pennsylvania** will do basic testing on ticks for residents of Pennsylvania for **FREE!** If you find a tick on you or your pet, whether embedded or not, and want it tested, go to **ticklab.org**. Once there you will fill out some basic demographic information, print your voucher, then mail voucher and specimen. You are not limited to one tick, they will test up to five.

After the Tick Research Lab of Pennsylvania has received the specimen they will notify you of the species of the tick identified and whether it was engorged with blood or unengorged. Then the lab tests for pathogens that might be in the tick. Once testing is completed you will receive a copy of the results.

The following "Basic panel" tests are completed at no charge to you: Borrelia burgdorferi, Ehrlichia chaffeensis, Francisella tularensis, Powassan virus General, Rickettsia rickettsia, Powassan virus Lineage II, and Powassan virus Lineage I. You can then use this report to present to your doctor or veterinarian.

This site also offers an Advanced and Comprehensive panel for a fee. The site also has some great information about tick ID, tick borne diseases and tick prevention.

# **Directions to Sulzbacher Demonstration Forest (WOSA property):**

The WOSA property is located along Big Creek Road, about 8 miles south of Clearville, Pa. There is no street address and limited cell service.

If you want to try your GPS, set it for **3057 Big Creek Road, Clearville, Pa**. Going south, this is the house just before the curve to the right and then the lane onto WOSA's property. You'll see the large WOSA sign.

From Bedford: Take Rt. 30 East toward Everett, then take the Right exit into Everett. Travel Business Rt. 30 through Everett and turn Right at the 2<sup>nd</sup> light onto Hopewell Street. Travel across the east end bridge, go up the hill, and turn left to stay on Rt. 26 South. Take 26 South for about 8 miles to Clearville.

In Clearville, **stay straight ahead**. The road becomes Rockhill Rd/Rock Hill Church Rd (Rt. 26 is a righthand turn – don't take 26S.) Stay on Rockhill Road for 0.6 miles.

Then take a right onto Big Creek Road. Stay on Big Creek Road for 6.3 winding miles. Continue past Shreves Chapel Road (dirt road on the Right) for 0.6 miles. You will pass a house on the Right before the road curves to the right. Just after the curve, **turn right** when you see the large WOSA sign. Follow the gravel lane up the hill. Park beside other vehicles in the big hay field. The gate is finished and locked but will be open for WOSA events. The trails in the Old Growth Forest stand and Louie's Campsite stand are blazed, but we need to do more trimming and trail definition to make them easier to follow.
