The Ada Slebodnick Subdivision Final Plan showing a side lot addition, complies with the townships Subdivision and Land Development Ordinance.

- The Cable System Franchise Agreement between Washington Township and Comcast of Pennsylvania. Agreement only deals with wired cable television and allows Comcast to make adjustments if another cable franchises would enter the area. Comcast would be notified and given an opportunity to meet the competitors offer. Term of agreement is ten years.
- Correspondence from the Wanzek Construction, LLC., dealing with the upgrades for the turbine wind farm. Estimated start date of turbine update is June 23, 2023. Four turbines in Washington Township will be updated by replacing the blades, nacelle, hub, and tower wiring. The Megawatts will increase as shall the annual windfarm allocation to the township in lieu of taxes. Permitting fees will be set as those adopted by Ordinance.
