#### Tim Paulus - Fire Department Report

Purchases

He presented a pricing spreadsheet and requested that 1,256 smoke detectors and 126 batteries as part of the FP&S grant be purchased for the lowest price he could find -- from Pettigrew Hardware -- for a total of \$27,583.30. The Township's match would be \$1,379.17.
