The Board of Trustees met at the Hampshire Township Administration Offices at 170 Mill Ave., Hampshire, IL on the 9<sup>th</sup> day of May, 2023 at 7:00 pm.

1) The meeting opened with the pledge to the flag. Mrs. Remakel then asked for any changes or additions to the agenda. Under Board of Trustee Comments, she would like to add Stan Walker presentation and Oath of Office for Dan Rowlett.

2) Minutes. The Board reviewed the Board of Trustee Minutes from April 11, 2023. A motion was made by Trustee Becker to approve them as presented. Trustee Gustafson seconded the motion and it was approved unanimously by all those present.

3) Treasurer's Report. The Board reviewed the April Treasurer's report. A motion was made by Trustee Paddock to approve the April Treasurer's report. Trustee Drendel seconded the motion and it was approved by all those present. A roll call vote was taken.

4) Public Comment. Rose asked about permits as the Assessor's office is not receiving them from the Village. Jody informed her that the information is coming from the software that the Village provides. Becky acknowledged having access to the software and will work on understanding the software more.5) Reports

<u>Assessor:</u> Assessor Penkaty reported that the timeline she gave herself to have the new assessments completed was Memorial Day weekend. She will have them done before that. Once the new assessments are done, she will be out measuring in Tamms Farm and Prairie Ridge as there is a lot to be measured. The phone has been busy since the tax bill came out. A lot of the calls are due to residents not having their senior exemption. Ms. Penkaty reported that she attend the last Village meeting and Trustee Aaron Kelly gave us a great compliment on our annual town meeting and encouraged others to attend it.

<u>Highway Commissioner:</u> Mr. Walker reported that all the trucks were tested and there was 1 truck that had an issue. It was taken to Diesel Works to be fixed. He took 22 tires down to County to be disposed of properly. These are tires that have been found in the ditches. They emptied and fixed the salt bins down at Petersen's. A total of 480 tons of salt was delivered this year. We are full and ready for next year. All the winter equipment has been taken off the trucks and put away and the trucks and mowers are ready for the

next season. Mr. Walker met with Peter Baker who will be doing the blacktopping in one of the subdivisions off of Higgin Road. They are ready to go, just waiting of the hot patch to be ready.

<u>Supervisor</u>: Supervisor Remakel reported that Burlington is up to date with their transportation agreement payments. She was asked to be on the Kane County Assistance Counsel regarding GA claims. Ms. Remakel reported that the Senior Program is going growing and that there were 30 who attended bingo just today. Yoga has increased to 10-15 people and all the overnight trips are filled with the 1<sup>st</sup> trip later this month. Mrs. Remakel reported on the accident with one of the senior vehicles. After a senior and his daughter were dropped off, the daughter backed her car into the tail light of the senior vehicle. The vehicle was repaired, but her issuance is supposed to be reimbursing the Township.

## 7) New Business.

<u>Approval of Intergovernmental Agreement for GA with Elgin Township.</u> There is no charge from Elgin Township for handling any of our GA claims. A motion was made by Trustee Gustafson to approve the Intergovernmental Agreement for GA with Elgin Township. Trustee Paddock seconded the motion and it was approved unanimously by all those present.

<u>Approval of the Appointment of the Decennial Committee Members.</u> The Decennial Committees need to consist of 2 members outside of the Township Board. The Township Committee will consist of Lori Marwig, Maureen McGreevy, and Connie VonKuedell. For the Road district committee, it will consist of Stan Walker, Don Rowlett, and Denise Rowlett (alternate). A motion was made by Trustee Gustafson to approve the Decennial Committee members to both the Town and Road committees. Trustee Paddock seconded the motion and it was approved unanimously by all those present. The 1<sup>st</sup> meeting of these committees will be June 6<sup>th</sup> at 6pm.

<u>Discussion and Approval of the Highway Commissioner Appointment.</u> Mr. Walker will be vacating the Highway Commissioner position effective 5/14/23. It was recommended that Dan Rowlett finish the Highway Commissioner term. A motion was made by Trustee Drendel to appoint Dan Rowlett to complete the remaining term of Highway Commissioner. Trustee Gustafson seconded the motion and it was approved unanimously by all those present. A roll call vote was taken.


