Young made a motion, seconded by Bruette, to approve the May 11, 2020 Town Board meeting minutes. All Ayes. MOTION CARRIED.

Young made a motion, seconded by Bruette, to approve the May 21, 2020 Board of Review meeting minutes. All Ayes. MOTION CARRIED.

Treasurer's Monthly Report; 2020; <u>Discussion and possible action:</u> CD renewals A. Monthly Report

The balances for all accounts as of April 30, 2020, are as follows: Checking - \$1,394.99;

Investment Savings - \$328,229.75; and Town CD's - \$ 128,952.33. Total town funds--\$458,577.07. Stands as read subject to an audit with the clerk.

Specific matters for discussion and possible action:

A. Change wage for Regina Woroniecki-Ziepke to \$14/hour—Cemetery Commission recommended Two new cemetery hires; Brooke Schweitzer, Keegan Morien

The Cemetery Commission, at their last 2019 meeting, had recommended a wage increase for Regina W-Z, as a cemetery employee. After some discussion, <u>Bruette made a motion, seconded by Young, to approve a \$14 an hour wage for Regina Woroniecki-Ziepke. All Ayes. MOTION CARRIED.</u>

After some discussion, <u>Young made a motion, seconded by Korth, to hire Brooke Schweitzer and Keegan</u> Morien at \$12 per hour for cemetery work. All Ayes. MOTION CARRIED.

B. Pat Williams, DBA Spooks on Spurr, is interested in applying for the Class B Liquor license that is available

Pat Williams is interested in applying for the remainder Class B Liquor license that is available in Maple Creek for Spooks on Spurr. Mr. Williams stated that he is a responsible license holder operating 3 different businesses with no issues. The Board consensus was favorable. Since liquor license applications need to be submitted at

least 15 days prior to action, Mr. Williams will submit the paperwork to the clerk and this will be on the July agenda.

Korth made a motion, seconded by Young, to approve Class B beer licenses to Kevin Clark, dba Autumn Wings Hunt Club and Pat Williams, dba Spooks on Spurr to expire June 30, 2021. All Ayes. MOTION CARRIED.

Bruette made a motion, seconded by Young, to approve a Combination Class B (beer, liquor) license to Sugar Bush Drifters Snowmobile Club, Inc., to expire June 30, 2021. All Ayes. MOTION CARRIED.

Class C wine licenses – July 1, 2020 to June 30, 2021

1. Pat Williams, DBA Spooks on Spurr

Korth made a motion, seconded by Young, to approve a Class C wine license to Pat Williams, dba Spooks on Spurr to expire June 30, 2021. All Ayes. MOTION CARRIED.

D. Operator License—Cheryl Rohan, 1215 W. Cameron Street, NL

Korth made a motion, seconded by Young, to approve an Operator's license for Cheryl Rohan for a 2-year term. All Ayes. MOTION CARRIED.

E. WTA membership dues

Korth made a motion, seconded by Bruette, to pay the Wisconsin Town's Association yearly dues of \$746.61. All Ayes. MOTION CARRIED.

F. Roads:

1. Church Street signs

Chairman Korth talked with Chairman Tank from the Town of Lebanon. Church Street is unique in that one side is located in Maple Creek/Outagamie County and the other side is located in Lebanon/Waupaca County. According to Chairman Tank, the DOT needs to approve the 25 miles per hour and a form needs to be filled out. They also feel that the \$250 estimate from Outagamie County Highway Department is too much. This will be postponed until next month.

2. Ditch Mowing

Chairman Korth hasn't heard from Outagamie County Highway Department as to when they will be mowing. Should they mow one or two passes? <u>Young made a motion, seconded by Bruette, to authorize the Chairman to decide how many swaths to be mowed on the roads after talking to the County.</u> . All Ayes. MOTION CARRIED.

3. Hintz Road construction update

Chairman Korth stated that August is the projected month for the construction.

4. Chip Seal update

Chairman Korth stated that August is the projected month for the chip sealing.

5. Electric Rewire Schweitzer Road

WE Energies will be doing an electric rewire at W10344 Schweitzer Road. The work is scheduled to start on or about 6/22/2020.

6. Culvert on Kickhafer Road

A culvert needs replacing on Kickhafer Road. There's a 24" in there now. Chairman Korth received a quote from the County. The estimate is for \$6,500 to include the pipe replacement with one apron end wall and rip rap plus the cost of the pipe; 24"-\$798.40 and 30"-\$936.00. There's another culvert at the other end of Kickhafer that needs replacing also. The board discussed replacing both right away. <u>Bruette made a motion, seconded by Young, to authorize the Chairman to replace one culvert on Kickhafer Road for the estimate of \$6500 plus a 30" culvert for \$936.00. All Ayes. MOTION CARRIED.</u> Chairman Korth will check on the condition of the other culvert and an estimate on that replacement.

7. Crackfilling

The Board decided not to do any crack filling this year.

G. County ½ percent revenue sharing-Resolution

After discussing participation in the ½ percent revenue sharing with Outagamie County for several months, the board decided to participate. The Clerk created the resolution needed to be sent to the County. <u>Young made a</u>

motion, seconded by Bruette, to approve Resolution 2020-01 Sales Tax Revenue Resolution. All Ayes. MOTION CARRIED.

H. Town Hall maintenance update; Town Hall use; Stilen Road posting board

Supervisor Young has been power washing the ramp and painting the front sign. Chairman Korth has the slab for the new posting board on Stilen Road. The clerk ordered the new board and it is in. Chairman Korth will install it. The clerk inquired about Town Hall use during the pandemic. This should be put on next month's agenda.
