Is there interest in my submission of this proposal? If so, I will prepare a proposal. In short, the proposal would recommend a series of calculations and derivations to demonstrate various mechanisms of explosions in piping which would include explosions in oil pipelines. The cost of the research would be approximately \$120,000 to include a final report summarizing the results of the calculations, and recommendations for future experimental research.

To summarize the present status of this work, I have attached a copy of an article to be published as a comment in the Editorial section of the August edition of the American Society of Mechanical Engineers (ASME) Mechanical Engineering Magazine, which is distributed to 133,000 engineers in 158 countries. A more detailed discussion of the theory with respect to nuclear facility hydrogen explosions will be published in the October edition of the ASME Pressure Vessel and Technology Journal. If this proposal is accepted, we can further the application of this new theory to better understand oil drilling pipeline explosions and better ensure safety in pipeline operations.
