### Show Rules & Regulations

Event hours: 10:00AM – 3 pm with BRUNCH being served at 10 am; Doll Show from 11:30 to 3:00  
We need to vacate the building by 4:00 or incur additional charges.

Set up is from 7:30AM to 9:30AM the morning of the show. Please check in immediately upon arrival.  
Parking: After unloading, please park along the drive or on the far ends of the lot to allow shoppers close parking.

Booth/table fees to be paid with this contract. Space is rented on a first come, first serve basis.  
Entry fees are based on a 'per table' basis. A standard 'table' is defined as approximately 2.5'x 8' in size, plus reasonable exhibitor access. Displayed items must occupy the space purchased as indicated above.

**TABLES AT THIS LOCATION ARE NOT SKIRTED!** Table covers must reach **TO THE FLOOR**. Bismarck Doll Friends reserves the right to have exhibitors remove display and merchandise items that may not be in keeping with the show's image.

Signs: We encourage special signs to highlight your product or service. Bismarck Doll Friends reserve the right to have Exhibitors remove signs and merchandise not in keeping with the show's image.

Your area must be ready for showing by **9:45 am**. All items for sale must have visible prices. Exhibits must remain in place, properly staffed and available to the public until 3:00 pm when the show officially closes. Brunch is served at 10:00 am. Exhibitors are encouraged to attend the luncheon to connect with your clientele and join us in the fun.

Early disassembly and packing is discourteous and unfair to the customers and can create unsafe conditions.

Floor selling will not be allowed within the exhibit hall. Only those who have paid for space will be authorized to offer items for sale.

Exhibitor conduct: Exhibitors shall abide by and observe all laws, rules, regulations and ordinances of any applicable governmental authority. Interference or obstructions of neighboring space, or actions that impede the aisles are prohibited. Loud or excessive noise is prohibited. ***Aisles and fire exits must be kept clear. Merchandise may NOT be displayed in front of the table or in the aisles. This is for safety of our customers AND to avoid damage to your merchandise!!!***

The exhibitor hereby agrees to indemnify, defend, protect, hold harmless and save Bismarck Doll Friends from any and all claims, demands, suits, liability, damages, loss, injury, costs, attorney's fees and expenses of any nature which might arise from any action or failure to act, or negligence of the exhibitor or any of its co-exhibitors, officers, agents, employees, representatives or assignees. Exhibitors are encouraged to insure themselves against loss and claims. Further, the exhibitor, co-exhibitor, agent, employee or assignee shall not hold the show producer, its employees, agents or assignees accountable or liable in case of fire, water, flood, earthquake or other acts of God or war, riot, or other forms of civil unrest or any accident or loss therein related. Any infringement of copyright or patent rules and regulations are the sole responsibility of the exhibitor. Bismarck Doll Friends and any employees, agents or assignees are not responsible for any actions of the event center employees, agents or assignees. Exhibitors will be held financially responsible for damage to the exhibition hall caused by the exhibitor or co-exhibitor, agent, representative, employee, or assignee. Smoking is allowed in designated areas only. The Fire Marshall will not permit smoking in the exhibit area.
