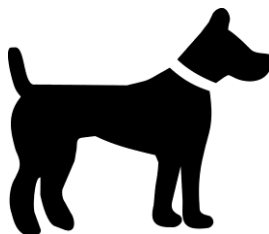

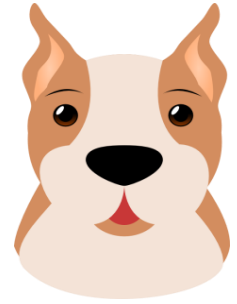

Legal "Stuff"

This agreement is between Animal Crackers and the pet owner whose signature appears below. This agreement will be effective each time Animal Crackers has this pet for boarding and does not need to be signed every time.

The pet owner represents that their pet is in all respects healthy and is current on vaccinations and flea protection, that the pet does not suffer from any illness or condition which could affect other pets or people who come into contact with their pet. Pet owner will also not hold Animal Crackers liable for any illness, etc. their pet may contact during their stay unless caused by negligence on Animal Cracker's facilities.

Pet owner agrees to be held responsible for any costs (medical, damage, etc.) that were caused by their pet (such as from biting, attacking, damage to property). Pet owner understands that if their pet shows aggression, for their pet and others safety, their pet may be confined to a kennel or pen. Pet owner also agrees to release Animal Crackers of all liability relating to the above.

Pet owner agrees to pay the rate for boarding that is in effect when their dog is at Animal Crackers. Pet owner also agrees to pay for any veterinary services that may be needed during their stay (Animal Crackers will try to contact the phone numbers given to us prior to any medical treatment, however, if the pet owner cannot be reached, Animal Crackers and the veterinarian will use their best judgement on the care needed and all costs will be paid by pet owner).
