AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF CISCO, TEXAS, APPROVING A NEGOTIATED SETTLEMENT BETWEEN THE ATMOS CITIES STEERING COMMITTEE ("ACSC") AND ATMOS ENERGY CORP., MIDTEX DIVISION REGARDING THE COMPANY'S 2019 RATE REVIEW MECANISM FILING; DECLARING EXISTING RATES TO BE UNREASONABLE; ADOPTING TARIFFS THAT REFLECT RATE ADJUSTMENTS CONSISTENT WITH THE NEGOTIATED SETTLEMENT; FINDING THE RATES TO BE SET BY THE ATTACHED SETTLEMENT TARIFFS TO BE JUST AND REASONABLE AND IN THE PUBLIC INTEREST; APPROVING AN ATTACHED EXHIBIT ESTABLISHING A BENCHMARK FOR PENSIONS AND RETIREE MEDICAL BENEFITS; APPROVING AN ATTACHED EXHIBIT REGARDING AMORTIZATION OF REGULATORY LIABILITY; REQUIRING THE COMPANY TO REIMBURSE ACSC'S REASONABLE RATEMAKING EXPENSES; DETERMINING THAT THIS ORDINANCE WAS PASSED IN ACCORDANCE WITH THE REQUIREMENTS OF THE TEXAS OPEN MEETINGS ACT; ADOPTING A SAVINGS CLAUSE; DECLARING AN EFFECTIVE DATE; AND REQUIRING DELIVERY OF THIS ORDINANCE TO THE COMPANY AND THE ACSC'S LEGAL COUNSEL. AN ORDINANCE OF THE CITY OF CISCO, TEXAS, AMENDING SECTION 10-19 "RATES" OF THE CITY'S CODE OF ORDINANCES ESTABLISHING SANITATION RATES; AND ESTABLISHING AN EFFECTIVE DATE. (First Reading)

Mr. Archer explained that our rates are contractually raised annually by Republic Services and the proposed ordinance is a recommendation of customer rates based on that increase. Councilmember Weger commented that two of the recommended rates were actually lower than the current rate and Mr. Archer stated that those rates should be the same as the current rate.

Motion was made by Councilmember Weger to accept the ordinance with the discussed amendment, second was made by Councilmember W. Johnson. Motion prevailed by the following vote:

M. Consider and Discuss 'No Wake' Designation at Lake Cisco.

Councilmember Weger asked if the 'No Wake' designation would automatically lift when the lake is below 1520 feet. Mr. Archer answered affirmative and added that the current lake level was 1520.79.

Motion was made by Councilmember C. Johnson to lift the 'No Wake' designation effective immediately, second was made by Councilmember Weger. Motion prevailed by the following vote:

The Council continued discussion as to whether the automatic 'No Wake' designation should be set to a higher elevation. Councilmember C. Johnson said he felt that 'No Wake' designations should be looked at on a case by case basis as opposed to automatically happening at a certain elevation. Mr. Diers spoke from the audience saying that he thought there was a problem of enforcement. Mr. Archer suggested making just the coves a 'No Wake' zone to which Councilmember C. Johnson reiterated that there was an issue of enforcing the regulation. Mr. Schanbacher also spoke from the audience saying that there used to be a 'No Wake' designation 50 feet from the shore all around Lake Cisco.

No further action was taken on this item.

N. Consider and Discuss Long Range Planning.

Mr. Archer commented that Labor Day would be September 2, 2019 and city offices would be closed.

Mayor Douglas added dates for upcoming events including the 4th Annual Big Dam Brisket Cook-Off on September 13-14; City wide garage sale will be September 28; Cisco Night Out will be October 12; and Trick or Treat night will be the last Saturday in October.

O. Announcements from City Council.

Mr. Archer shared a letter and postcard the city had received showing Williamson Dam and the old swimming pool that had come from a family in Pennsylvania.

Mr. Archer informed the Council and guests that Mr. Randy Johnson, the Water Treatment Plant Supervisor, will celebrate his 35th anniversary with the City tomorrow.

Motion was made by Councilmember Forester to adjourn, second made by Councilmember R. Johnson. Motion passed unanimously and the meeting adjourned at 6:34 p.m.
