## KENTUCKY

Kentucky was never a territory; instead it was part of Virginia until it won statehood in 1792. Like its predecessors, Kentucky initially was organized as a single district with one judge.<sup>1</sup> The court exercised complete federal jurisdiction, and was used as the model of such as other states were organized. In 1901 Kentucky was reorganized into Eastern and Western districts, with one judgeship each.<sup>2</sup>

KY.WD.01 is the original seat, and had jurisdiction over the entire state until the 1901 reorganization (see the succession line of Judge Innes). KY.ED.05 was created as a temporary seat in 1978, with the condition that the next vacancy on the court would not be filled.<sup>3</sup> When Judge Moynahan retired in 1984, KY.ED.01 ended and KY.ED.05 effectively became the regular line. KY.ED.06 was created pursuant to Section 372(b) of Title 28 of the United States Code, when the circuit judicial council certified the disability of Judge Unthank (KY.ED.02). KY.ED.06 was authorized subsequently.

Kentucky has been in the Sixth Circuit since 1862. The state has ten judgeships–five in the Eastern District and four in the Western district. The tenth seat, KY.EWD.01, is unusual in that it was created as a transient position in 1936, and never assigned permanently to either of the districts.
