**ITEM 4:** PRINT TELEPHONE NUMBER APPLICANT CAN BE REACHED DURING NORMAL BUSINESS HOURS.

**ITEM 5:** ENTER THE ADDRESS WHERE SIGN WILL BE PLACED.

**ITEM 6:** ENTER TAX MAP NUMBER WHERE SIGN WILL BE PLACED.

**ITEM 7 & 8:** MINIMUM SETBACK REQUIREMENTS WILL BE COMPLETED BY TOWN HALL.

**ITEM 9:** ENTER THE TYPE OF SIGN TO BE CONSTRUCTED.

**ITEM 10:** SIGN REQUIREMENTS WILL BE COMPLETED BY TOWN HALL.

**ITEM 11:** CONDITIONS (IF APPLICABLE) WILL BE COMPLETED BY TOWN HALL
