# **Engineers Report:**

As Discussed:

1. Rotary Press And Pump Station Screen

Project would require a Part II permit which will take 6-10 months.

Leadtime for press is an additional 8-10 months.

New Engineering Agreement-Total Engineering is \$183,000.00

- Design and construction management - \$85,000.00- Building Permit-\$2,500.00- WQM Part II-\$20,000.00- Mapping- \$6000.00- Funding Admin-\$40,000.00-Construction Inspection-\$30,000.00.

# 2. PENNVEST Funding

Planning and consultation meeting was held.

Project cost estimated at \$1,100,000.00 includes sludge press and pump station screen.

PENNVEST anticipates Project will be 100% Loan (1.0% for year 0-5.-1.743% for years 6-20)

Monthly payments of \$5,431.82 or \$5.10 per customer.

Operating \$51,000 per year in black- profit

\$1.11 per customer monthly increase if \$51,000.00 is applied to the loan.

## 3. Storage Building

Current size is 32'X 52'X16' with four garage doors sized 10 X 12.'

Insulation, electricity, water, and steps are not included.

Bid concrete, fence, and barn trusses as additive alternatives.

Project will be design build.

The engineer presented a pole building site plan for the proposed storage building.

The use of Knop and Klatt for the catch basin at the wastewater treatment plant.

# **WWTP Report:**

### As Discussed:

- Submitted monthly DMR Report.
- Downloaded flow meters. The Plant Manager found a new portable flow meter that is recharged by usb port, meters automatically begin calibrating the flow whether there is a large flow or small. Board member Dennis Beck to investigate the Exeter vendor at the PA

- Rural Water Conference. New flow meters to track infiltration with a price of \$3,000.00 for each portable flow meter.
- Replaced a ballast for U. V. lights also cleaned and serviced the Ultraviolet Light disinfection system.
- Found a leak on the effluent water piping system in Tunnel #2, plant employees cannot repair off a ladder, needed scaffolding to access.

**Motion** made by Dennis Beck 2<sup>nd</sup> Jeff Hite to authorize the plant manager to purchase three sections of scaffolding for the wastewater treatment plant. Roll call, All in favor Motion passed.

- Two plant alarms, one for the control panel losing power because backup power stopped working, need to be replaced. Cambria systems located a new one, Second Alarm was for a blower failed to start.
- Sunday the 17<sup>th</sup> a grinder pump in Cassandra failed and was replaced with spare.
- ➤ Hauled out two roll offs of sludge.
- ➤ Kubota quote with cab- tabled.
