Minutes of February 5, 2024

The Huntington Township Trustees met in regular scheduled meeting at 7:00 PM called to order with the pledge of Allegiance. Attendees: Robert Holmes, Walter Rollin, Jed Lamb, Sheila Lanning, Matt Combs, Nora Klebow, Frances Rollin, Doug Rief and Lyn Ickes. *Motion* by Rollin with a second by Holmes to approve the minutes of the January 15, 2024 regular scheduled meeting and the Work session of January 5, 2024 as written. Roll call: three yeas. Checks 10559-10579 and payments totaling \$17,954.15 were approved for payment. *Motion* by Holmes with a second by Rollin to approve the January Financial reports with year to date Revenue \$20,063.14, Expenditures \$8,307.32 and bank balances of \$599,430.30. Roll call: three yeas. Chairman Lamb stated the agenda would be changed to allow the public to speak first and that anyone wanting to speak should designate their intension when signing the attendance sheet.

Chairman Lamb opened two bids received for hauling of stone to the Township Stockpile for 2024. Sarver Paving and DJ Rief were the bids received. After tallying and reviewing the bids, *Motion* by Holmes with a second by Rollin to award the bid for stone hauling to the Township stockpile beginning 2/6/2024 to DJ Rief. Roll call: three yeas.

PUBLIC COMMENTS- Frances Rollin questioned the new septic tank fee. Lyn Ickes asked permission to hold an Easter Egg activity if time to plan allowed for 2024 or 2025. *Consensus* to approve of holding an Easter Egg activity.

COMMITTEE REPORTS:

WATER- Lamb: meeting is upcoming

LORCO- Lamb: meeting is upcoming, looks like the custodial account is updated for the next meeting.

AMBULANCE- Holmes: Board meeting is 2/13/2024, training is 2/6/2024, changes in structure included two full time lieutenants and an assistant director.

FIRE- Rollin- meeting is tomorrow, recognition dinner went well.

SHERIFF- 16 incidents in January.

OPWC & SWAC- Combs: Applying for Storm Water mini grant for culvert on Hawley Road. That would make 3 culvert projects on Hawley Road. Holmes: The County's Griggs Road culvert work was bid at \$121,558.00 with Ohio Public Works Commission paying \$106,832.00 and the County \$14,726.00.

CEMETERY- Holmes: gave Rollin the Lorain County Township Associations 2023 report on Cemetery rates in the County.

ROADS- Combs: Took a look at Pratt and Stewart Roads for future repairs. Lamb: take a look at Hawley Road south, there are a few pot holes.

SAFETY SERVICE BUILDING- Ickes: Reviewed the USDA loan/grant application and it looks like it would be a 10 year "loan" with interest. This is a possibility for the HVAC or other portion of the building, still waiting on the determination from Dick Stein's office. Expect an answer in July-November time frame.

EQUIPMENT- Combs: would like M&R to look at the brakes and review the trucks before the black top season begins. Discussion on overall maintenance of trucks with *Consensus* to get a quote from M&R on the needed work.

ZONING- Klebow: reviewed report dated 2/5/2024. Talked with the newest Prosecutor to be assigned to Township Zoning. Holmes: check on zoning for Marijuana for Zoning Commission.
