Discussion of Potential Interlocal Agreement

Objective:

Request for Board discussion of a potential interlocal agreement between Immokalee Fire and North Collier Fire.

Background Information:

On June 16, 2016, the Boards of Commissioners for Immokalee Fire and North Collier Fire met to discuss the potential for additional interlocal agreements. This meeting is a follow-up to that meeting.

Considerations:

Currently, Immokalee Fire and North Collier Fire are already entered into the following interlocal agreements for:

- Fleet Maintenance
- Plans Review
- New Construction & Existing Building Fire Inspections
- Integrated Training & Education

Additionally, Immokalee Fire and North Collier Fire cooperatively in the following areas:

- North Collier Fire has assumed the role of Authority Having Jurisdiction (AHJ) for Immokalee Fire since the retirement of Fire Marshal Leo Rodgers;
- The Districts share bunker gear cleaning machine;
- The Districts assimilate various operational responses;
- North Collier Fire has assisted with Immokalee Fire's audit preparation; and
- North Collier Fire has assisted with Immokalee Fire's grant maintenance.

Recommendation:

Staff recommends the Boards discuss options for a joint management agreement and to provide direction for the creation of an interlocal agreement to be brought back to the respective Boards at a future meeting.
