Postcript to meeting

Email from Phil KItely (Chair) on January 17th 2017

Following a discussion with Colin Burton, the builder, he has advised that it would be prudent not to have the base of the extension exposed for a length of time as we originally intended. He has indicated that he would be prepared to complete the structure including external walls and roof for approximately £7-8000. He also said that he would be willing to forego payment until such time as the committee have the necessary funds available.

Clearly we already have sufficient funds which may well be augmented if we are successful in obtaining the grant aid which we are currently applying for. Although this represents a departure from our original plans this does seem to be a viable way forward which would ensure the weatherproofing of the building works carried out.

I have asked Colin Burton to provide a definite estimate for completing the structure but based upon his initial estimate the financial situation would be as follows -

Cost of the base	£4,200
Cost of completing structure	£7-8,000

This potential expenditure would leave £2-3,000 operational costs still available in the village hall funds. Rather than organise a special meeting I am issuing this e-mail seeking your views and opinions as a matter of urgency so that I can inform Colin Burton of our decision. If you require further information please let me know.

Responses received from committee members.

Following email from Phil Kitely on January 21st 2017:

Hi everyone. Thanks for responding quickly to my previous email. Everyone who responded is in favour of carrying on from the base and building the structure. This is a majority of committee members and I have accordingly instructed Colin Burton to carry on.
