Open Men BB, Open Figure and Bikini – Top 5 in each class qualify for Jr USA, Jr Nationals and North America.

Open Men Physique and Open Women Physique – Top 5 in each class qualify for all national level events.

NOVICE DIVISION – Competitors who never won the Overall at an NPC event.

TRUE NOVICE DIVISION – Competitors who never competed in that Division at an NPC event.

JUNIOR DIVISION – Competitors up to and including the age of 23.
