MESSAGE FROM THE CEO

To the Shareholders and the Board of Directors:

This past year has been an exciting growth year for our companies and has also been one of our most profitable years. As you may recall, last year we acquired S&K Environmental, LLC. This company has filed for 8(a) certification and will focus its business on environmental restoration work and engineering. We have been working on acquiring a company with engineering expertise to fold into S&K Environmental. As I mentioned in last year's annual report, we were then in the process of establishing a security company. I am pleased to state that the company has been established under the name of S&K Security Group, LLC. We expect to set up offices in Tennessee later this year.

The board of directors recently approved the establishment of S&K Logistic Services, LLC. This company, upon formal approval by the shareholder, will focus initially on the United States Air Force. SKT, from its inception, has had a strong and positive customer relationship with the USAF.

Recent congressional legislative initiatives to alter SBA's 8(a) procedures continue to be of concern. I made personal calls on Montana's congressional delegation to emphasize the importance of the 8(a) program to the viability of our companies. Our lobbyist in Washington, D.C., closely monitors these activities. In fall 2010 I traveled to the Republic of Turkey as a member of a trade and cultural delegation. We recently followed up on that trip with a meeting in Washington, D.C., with a consultant who represents a Turkish trade association. We hope to develop cooperative ventures with Turkish businesses specializing in defense-related work.

I want to personally thank the staff of the SKT family of companies for their exemplary job performance. It is through our combined efforts that we continue to grow and prosper.

While SKT's structure has changed and its accomplishments have increased, our true mission remains the same: to grow each company, to provide a sustained dividend to the Confederated Salish and Kootenai Tribes, and to secure employment opportunities, both on and off the reservation. All SKT's enterprises were started with modest capitalization from the Tribes, and since 1999 SKT has paid the Tribes dividends to be used for Tribal purposes. The companies maintain a Native American preference hiring policy designed to foster the employment and subsequent economic support of Tribal members.

S&K Environmental, LLC (SKEr, LLC) was acquired by SKT, Inc., in December 2009. The company utilizes innovative technology and pioneering science to restore rivers, wetlands, and uplands throughout the West. As a Tribally owned business, we recognize the cultural and historic importance of the lands we work upon, just as we recognize the complexities of altering sensitive environments. Whether we are recontouring a stream with specialized equipment or hand-planting native vegetation, our goal is to encourage natural landscapes that exhibit a composition, structure, and function that is diverse and self-sustaining.

SKEr also has the experience, personnel, and equipment to perform civil construction projects. The company, which has been in existence for several years, intends to expand its ability to compete statewide and regionally. As a member of the SKT, Inc., family of companies, SKEr will strive to become one of the premier environmental restoration companies in the West.

SKEr has developed its reputation by exceeding the standards and specifications for any project or task undertaken. The company's values encompass a strong commitment to quality, dedication to employee growth, and responsibility for the health of our planet. SKEr provides an active training program, offering all employees the opportunity to upgrade their existing skills, as well as training in safety, health, and new technologies.

TerraEchos, Inc., a subsidiary of S&K Technologies, Inc., is a Montana-based, Tribally owned company providing Adelos[®] S4, a leading covert intelligence and surveillance sensor knowledge system for protecting high-value critical infrastructure, monitoring sensitive perimeters, and securing vulnerable borders.

Adelos[®] S4 combines patented U.S. Navy technology, advanced "data in motion" processing analytics, and superior geospatial messaging and exploitation sytems to deliver the most sophisticated sensor knowledge system in the world. The system's single fiber optic cable, acting as a dense, covert first line of surveillance and intelligence, is buried at varying depths in the ground or underwater. Adelos® S4 can instantly identify, distinguish, and classify a variety of objects detected by the fiber optic sensor. Detected acoustic signals are monitored continuously in real time and are characterized to determine the nature of the intrusion. Adelos® S4, a "system of systems," revolutionizes how we monitor, secure, and protect our most sensitive resources.

TerraEchos was honored to receive Frost & Sullivan's 2010 North American New Product Innovation of the Year Award in the category of Fiber Optic Sensors for Border Security. The Adelos® S4 fiber optic sensor solution was singled out for its innovative nature, use of leading-edge technology, and value to the customer. In addition, TerraEchos received IBM's 2010 CTO Innovation Award, which recognizes IBM business partners for innovative, one-of-a-kind solutions in information management.

TerraEchos is presently working cooperatively on research and development projects with the Naval Undersea Warfare Center and recently received sponsorship from the National Security Agency, enhancing the company's future business opportunities. The company also entered into its first commercial license agreement with IBM as an original equipment manufacturer of InfoSphere Streams, a differentiating capability incorporated in the new Adelos[®] S4 v1.5 system. TerraEchos remains focused on three associated market sectors: high-value critical infrastructure perimeter security, border security, and force protection for the United States' forward deployed military. By delivering solutions that satisfy growing government and private sector security demands, TerraEchos is now well positioned to remain ahead of its competition in the intelligence, surveillance, intrusion-detection, and monitoring marketplace.

Despite a slowdown in our economy, the most recent Department of Labor forecast predicts that the number of security guard positions will grow by 14 percent (or 175,000 new jobs) in the next five years.

As a spin-off security company offering an extensive line of personnel protection and installation security services, the new company will take advantage of a long history of 8(a) opportunities in an increasingly hostile and changing political environment. The security vertical market has seen growth from approximately \$50 billion at the time of 9/11 to \$100 billion in 2006, with a forecast of \$200 billion in 2011.

S&K Technologies, Inc., continues its progress as a parent company. The accomplishments of each of our subsidiaries have provided unique and sometimes challenging opportunities for growth. The start-up of the new security company (S&K Security Group, LLC) is proof that SKT is evolving and changing to better fit the needs of our customers.
