



First Class Petty Officer Felix B. Stewart, USN (Ret) August 12, 1943 - October 19, 2018

S/M Stewart was a FRA Member of 38 years. S/M Stewart retired from United States Navy in 1984. He enlisted in 1961 and served with the USS Will Rodgers "SSBN-659" as a medical Corpsman during his service with both the Navy and the Marines Corps. After his retirement from the Navy he was employed by the United States Post Office, Gaithersburg, MD.

S/M Stewart was an active member of the Tri-State Base of Submarine Veterans; a life-member of both the American Legion Post #68 Twinbrook, MD where he was part of the color guard and the V.F.W. Post 2562, Twinbrook, MD where he served as chaplain and other committee chairs. He was also a member of the Washington-Rockville Elk's Lodge #15; the Grand Lodge of A.F. and A.M. of Connecticut; and the Fleet Reserve Association.

Americanism Essay Contest For Grades 7–12

FRA sponsors an annual essay contest to promote the spirit of Americanism and patriotism among our country's youth. FRA's Americanism Essay Contest is open to all students, grades 7 through 12, including those who are home schooled. Students are invited to submit a 350word essay through an FRA member or local FRA branch before the December 1st deadline. Local winners are forwarded for competition at the regional level and regional winners compete for national prizes.

The grand national winner will receive \$5,000, with additional prizes for the top three essays in each grade category (\$2,500 for first place, \$1,500 for second place, and \$1,000 for third place). Each national winner will receive an attractive plaque citing his/her achievement, and every entrant judged at the national level receives a certificate of recognition. Additional prizes may be awarded to students winning at local and regional levels of competition.

Subj: Synopsis of 91st Fleet Reserve Association

Shipmates, first it was an honor for me to represent our branch at the 91st Fleet Reserve Association's National Convention held at the Omni Hotel in San Antonio, TX 24 September to 30 September 2018. The week was full of activities to downtown San Antonio, to a great Welcome Aboard Party that had two bands playing – a Mariachi group and an old fashion rock group. After opening ceremonies, committees met to finalize their end of the year reports to the delegates and I'll include the results at the end.

General Resolutions:

None Received

Constitution and Bylaws Resolutions:

- 1) Resolved that Article 3, Section 301, C&BL, FRA be amended to read as follows:
 - "Section 301, Eligibility for membership in the FRA shall be open to *all* personnel who have served or are now serving in an enlisted status or *in an officer status* in the United States Navy, United States Marine Corps, and United States Coast Guard, qualified United States Merchant Marine and United States Naval Academy Midshipmen, United States Coast Guard Cadets and United States Merchant Marine Midshipmen regardless of length of service, including reserve components." Committee recommended: Out of order.
- 2) Resolved that Article 7, Section 701(d) be amended to read as follows:
 - "Section 701(d). The Annual Convention on alternating years shall elect for a two-year term the National Vice President and National President, for a three year term the National Executive Director in a year the number is divisible by three. Committee recommended: Disapproval Delegates Defeated this."
- 3) Resolved that Article 7, Section 701(e) be amended to read as follows:
 - "Section 701(e). Regional Presidents and Regional Vice Presidents shall be elected for a two-year term. In the event a region fails to hold a convention for such elections, and the National Convention has been canceled, vacancies of the offices which are due to expire shall be filled by the National Board of Directors as provided in Section 705(a)." Committee recommended: Disapproval Delegates Defeated this.
- 4) This resolution had a lot of discussion dealing with the Duties of the National Committee on Membership and Retention.
- I believe that the National President Appoints the Chairman to a three year term, with Regional Vice Presidents serving their year as RVP on this very important committee.
- 5) This resolution was very similar to #4 above and since #4 was finished business, #5 is Out of Order

Standing Rules:

SRR-1, establishes the Standing Rule setting up the Veterans Service Foundation.

- SR-12 The FRA Veterans Service Foundation
- SR 12(a) The Fleet Reserve Association established the FRA Veterans Service Foundation to educate current and former enlisted members of the US Navy, Marine Corps and Coast Guard and other uniformed service about their VA benefits; advocate and provide without charge appropriate accredited representation to veterans and their dependents before the Department of Veterans Affairs (VA); and other purposes.
- SR 12(b) The FRA Veterans Service Foundation is recognized as a separate 501(c)3 tax exempt organization per the IRA determination letter 29 August 2017, and the Commonwealth of Virginia Certificate of Incorporation and Articles of Incorporation 29th March 2017, and functions under specific governing documents.
- SR-12(c) The Directors of the FRA Veterans Service Foundation will consist of seven (7) members in good standing of the FRA, elected by the delegates of the FRA National Convention and the FRA National Board of Directors as per the foundation's bylaws.
- SR-12(d) The FRA National Board of Directors (NBOD) has oversight authority regarding the FRA Veterans Service Foundation although the Foundation is a separate and distinct entity.

SR-12(e) The Foundation leadership will report at least once annually to the FRA NBOD to include financial reports associated with donation receipts, awards required IRS reports and administrative expenses."
