III. CORRESPONDENCE: Tim: Discussed grant offer from Portage County Regional Planning for community development grant relating to lower income region, and flood and tornado damage. Trustees to review to see if township qualifies, however seems unlikely.

Chris: Discussed closure of Town hall and need to reimburse one individual for town hall deposit. He also discussed cleaning and disinfecting town Hall. He has a bid for \$250.00. Jeffrey: Asked for opinion of other trustees regarding Dumpster Day and Memorial day parade. Trustees will postpone Dumpster and change information on the township center sign.

also discussed Edinburg townships present participation level in the 2020 census, at 29.4%, encouraging others to push for compliance especially since if you don't do it they will come to your door. Also he reported the Portage County Recycling employees will no longer leave truck to clean up area around recycling dumpsters when picking up. road department will need to work to keep the area picked up.

Tim: Mentioned he has reviewed and found that a lot of the road departments around us have shut down. The road department he works for has not, however, is allowing employees to vary work and schedule based on weather and demand, and ability to social distance. He has spoken with Kevin and Note who reported they can practice social distancing and continue work. Office is however closed to public. Jeffrey stated the fire department has also posted they are not open to the public just walking in.

Other trustees reported they agree with decision, as long as they are aware they are not being forced to come to work especially if they feel sick or family members are sick. Further discussion of Rootstown and Stark County totally shutting down road departments as well as crew rotations at the County level.

Mentioned potential to assist with fire department, However, Jeffrey mentioned limitations in runs with only one fire fighter.

Time: Reviewed road department report. Items:

Received a bid for stump grinding of 27 stumps thru-out areas by township hall, cemetery, park. Priced at \$35 a stump, \$945.00.

Chris read fire department summary. Items reported included maintaining all precautions set by UH, CDC and Portage EMA due to coronavirus. Fire department personnel are disinfecting station and equipment after each call. All department training has been suspended with requirements able to be met online.

The primary valve has been repaired on 1513, waiting on quote from Findley on updating hydraulic system for generator. 1513 need to have front spring shackles replaced and then front end alignment. 1512 also needs front end alignments and new front tires.

Further discussion occurred regarding backing up of septic system and also replacement of toilet men's room. Carpet also needs replaced.

Tim said Kevin is replacing toilet. Jeffrey discussed options regarding quote for generator only from Findley.

Alliance and Stuber spring discussed regarding fixing fire vehicles. Plumbing issues discussed regarding Septic system and problems especially during heavy rain. General discussions regarding solutions.

Chris discussed need to move ahead with new fire station. He feels something needs to move forward this year. Trustees discussed solutions now and then full replacement when new fire department is built in 2 years.
